DATE OF PROCEDURE: April 18, 2018 PATIENT LOCATION: J-ENDOSCOPY

INDICATION: As you know Kathy has had severe pouchitis refractory to a number of medications including azathioprine and Entyvio. She seemed to do better with infliximab and azathioprine. She started on CBD oil and THC. With this, she was markedly better and decided on her own to stop both the infliximab and azathioprine. She has been off medicines completely now for over 3 months. She is perfectly well, averaging 6 bowel movements per day with no bleeding despite a therapeutic INR at 2.8. She was in the Emergency Room in Windsor with an episode of vertigo last week. An MRI showed an old cerebellar stroke. She spoke with Dr. Kovacs, who did not think there was any need to change her therapy and she carries on with the Coumadin, although did hold 1 dose last night.

PROCEDURE: She was premedicated with propofol as per Anesthesia. The Olympus pediatric gastroscope was passed into the pouch. This was a totally normal appearing pouch with no evidence of inflammation or Crohn's disease. The blind end was normal as was the small bowel leading into the pouch. I was able to go up this approximately 20 cm and there was no evidence of Crohn's disease.

I took 1 biopsy from the distal ileum and a single biopsy from the pouch and put them in the same bottle for documentation as Kathy is going to give a talk about her experience to patient's early next week.

The procedure was tolerated well.

CONCLUSION: Ileal pouch in complete remission.

RECOMMENDATION: It is difficult to say for sure whether the CBD oil and THC is what has caused the complete mucosal remission, but at any rate, she is doing extremely well on it, is not requiring any other medications, and obviously there is no need to make any changes.
