CONVERSION OF CONVERTIBLE NOTES PURSUANT TO FINANCING ARRANGEMENT BETWEEN VALOE CORPORATION AND BRACKNOR INVESTMENT

The Board of Directors of Valoe Corporation (the "Company") has, pursuant to the terms and conditions of the financing arrangement between Valoe Corporation and Bracknor Investment announced on 19 April 2017, resolved to approve the request of Bracknor Investment to convert a proportion of EUR 50,000 of the convertible notes to the shares in the Company at conversion price of EUR 0,45 per share. The conversion shall be executed by transferring a total of 111.111 treasury shares to Bracknor Investment. After the transfer the Company will have in total 1.331.262 treasury shares.
