## CONVERSION OF CONVERTIBLE NOTES PURSUANT TO FINANCING ARRANGEMENT BETWEEN VALOE CORPORATION AND WINANCE

The Board of Directors of Valoe Corporation (the "Company") has, pursuant to the terms and conditions of the financing arrangement between Valoe Corporation and Winance announced on 22 April 2020, resolved to approve the request of Winance to convert the EUR 37,000 convertible notes portion of the commitment fee to the shares in the Company at conversion price of EUR 0.05 per share. The conversion shall be executed by transferring a total of 740,000 treasury shares to Winance. After the transfer, the Company will have in total 616 treasury shares.
