

ENGLISH SUMMARY OF THE DRAFT RESTRUCTURING PROGRAMME OF VALOE CORPORATION

1 Summary of Objectives and Main Content of the Restructuring Programme

This summary is prepared based on the draft restructuring programme of Valoe Corporation submitted by the administrator to the District Court of Northern Savonia on 24 June 2024. The summary contains a general overview of the relevant provisions included in the draft restructuring programme. The purpose of this summary is informative and to give creditors a general overview of the contents and proposals of the draft restructuring programme.

This summary is not an exhaustive description of draft restructuring programme and does not in any way replace the draft restructuring programme or be relied upon. The position of creditors is determined solely based on the draft restructuring programme. Creditors are advised to seek legal counsel to determine the effects of the restructuring programme on their position.

This summary may contain information which unintentionally contradicts with the draft restructuring programme. However, only the draft restructuring programme may be considered authoritative.

2 Confidentiality

This summary contains confidential information in respect of which creditors and other interested parties are reminded of the following confidentiality provisions. Sections of this summary marked with grey highlighting as well as Appendices 6.3, 20.1 and 22 in their entirety are subject to a secrecy order by the District Court of Northern Savonia.

Restructuring of Enterprises Act 14 § / Confidentiality

The administrator, a member of the creditors' committee or a creditor, their employees or their assistants or experts may not, without authorisation, disclose or use for private gain any information concerning the debtor's financial situation, business relations or business secrets which they have obtained in the course of the proceedings.

Restructuring of Enterprises Act 95 § / Liability for compensation for breach of the obligation of confidentiality

Any person who intentionally or negligently breaches the obligation of secrecy provided for in § 14 shall be liable to compensate the debtor for any damage caused to him as a result.

Penal Code 30:5 / Breach of a trade secret

Any person who, for his own or another's financial gain or for the purpose of injuring another, unlawfully discloses a trade secret belonging to another or unlawfully uses such a trade secret of which he has become aware.

1) while employed by another,

2) as a member of the supervisory board or board of directors of an entity or foundation, as managing director, auditor or administrator, or in a similar capacity,

3) in the performance of a task on behalf of another or otherwise in a confidential business relationship; or

4) in the context of the restructuring of a company,

shall be fined or imprisoned for a term not exceeding two years for breach of a trade secret, unless the offence is punishable by a more severe penalty elsewhere in law.

This Article shall not apply to an act committed by a person referred to in paragraph 1(1) two years after the end of his period of service.

An attempt is punishable.

Insider information

Valoe Corporation's shares are listed on the Nasdaq Helsinki Oy stock exchange. The company is subject to the legislation and other regulatory requirements applicable to listed companies. This summary contains information marked in grey or marked confidential which may constitute inside information.

3 Objectives of the Restructuring Programme

The aim of the restructuring programme is to restructure the Company's business, maintain its competitiveness in its industry and restructure the Company's debts only to the extent necessary to achieve the Company's restructuring objective.

The restructuring programme has sought to introduce flexibility by offering creditors the possibility to convert unsecured restructuring debt into shares in the Company. The remainder of the unsecured debt will be subject to a payment schedule under the Restructuring of Enterprises Act.

4 Restructuring and Repayment of Restructuring Debts

4.1 Restructuring debts of the Company

The total amount of restructuring debts is EUR 23,882,907.47. The restructuring debts of the Company can be categorized as follows:

Under the Restructuring of Enterprises Act, a debt is considered secured insofar as the value of the security at the time of commencement of the restructuring proceedings less the costs of the realisation of the security is sufficient to cover

the debt secured by the security. The part of the debt not covered by the value of the security is considered unsecured restructuring debt.

With regards to debts secured by a business mortgage, a debt is considered secured insofar as 50 percent of the value of the assets under the business mortgage at the time of commencement of the restructuring proceedings covers the debt. The part of the debt not covered by the value of the security is considered unsecured restructuring debt.

The restructuring debts of the Company are listed in Appendices 5.3.1 to 5.3.8.

4.2 Restructuring Measures Under the Restructuring Programme

4.2.1 Secured Debts and Debts Secured by a Business Mortgage

The debt capital of secured debt and debt secured by a business mortgage cannot be adjusted and must be repaid in full.

The administrator proposes that such debts are repaid under a four-year repayment programme set out in Appendices 18.2 and 18.3.

Under the Restructuring of Enterprises Act, secured creditors shall be paid interest that safeguards the current value of the security. The administrator proposes that interest on secured debts and debts secured by a business mortgage is paid at a rate of 12-month EURIBOR + 2 percent, and that accrued interest is paid at each instalment.

4.2.2 Debts Under Public Law and Other Unsecured Debts

Under the Restructuring of Enterprises Act, debts under public law are entitled to equal payment with other unsecured debts.

The administrator proposes that all unsecured restructuring debts are adjusted by 90 percent, whereby 10 percent of unsecured restructuring debts are to be repaid during the term of the restructuring programme. The payment programme for debts under public law is set out in Appendix 18.4 and for other unsecured debts in Appendix 18.5.

No interest is paid on unsecured debts.

4.2.3 Conditional and Maximum Amount Debts

Conditional and maximum amount debts are restructuring debts, the basis or amount for which has not become final at the time of submitting the restructuring programme. Such debts are entitled to payment based on their final amount on equal terms with other debts of the same priority.

The administrator proposes that an adjustment corresponding to other debts of the same priority is applied to such debts upon the debt becoming final. At the time of the debt becoming final, a creditor of such debts is entitled to receive payment corresponding to the same portion of the already paid amount to other creditors of the same priority. The remainder of the payable amount based on such debts shall be paid in corresponding instalments as with other debts of the same priority.

4.2.4 Disputed debts

Of the restructuring debts of the Company notified by creditors, EUR 4,394,692.36 has been debts which the administrator has deemed to be disputed. Upon deciding on the handling of the draft restructuring programme, the District

Court shall determine to what amount such debts shall be taken into consideration in the restructuring programme. The District Court may also direct a creditor of such a debt to bring the matter to be heard in separate court proceedings or other applicable proceedings to determine the final amount of the debt.

Creditors of disputed debts will not receive payment based on disputed debts until the basis for the dispute has been finally resolved. However, the Company is obligated to pay an amount that corresponds to 50 percent of the amount payable based on such debts to a separate escrow account of the supervisor of the restructuring programme in order to safeguard repayment to such creditors in the event that the Company would incur a payment obligation to the creditor.

4.2.5 Debts of Lowest Priority

Debts of lowest priority refers to voluntarily subordinated debts, capital loans or other debts which by law may only be paid after all other debts have been repaid.

As unsecured debts are adjusted in the restructuring programme, no payments will be made based on debts of lowest priority. Debts of lowest priority are consequently fully written down in the restructuring programme.

4.3 Position of Creditors Without the Restructuring Programme

Should the restructuring programme not be affirmed, the administrator concludes that the Company will most likely enter into bankruptcy proceedings.

The administrator has prepared a calculation of the possible outcome to unsecured creditors in the bankruptcy of the Company. The calculation is based on the best assessment of the valuation of the assets of the Company in such a scenario.



Based on the calculation, the administrator estimates that unsecured creditors would be able to recover 0.67 percent of their receivables in the bankruptcy of the Company.

Debt Conversion

The restructuring programme includes the right for unsecured creditors to convert their restructuring debts into shares of the Company. Creditors willing to exercise this right are to give a binding and irrevocable undertaking to the Company within two weeks (2) of the affirmation of the restructuring programme by the District Court. All unsecured creditors are subject to the same debt restructuring measures. However, a creditor is entitled to select either payment in money under the payment programme, or payment by way of a conversion of the full payable amount to shares of the Company.

The Company's obligation to enable such a conversion is implemented by a provision whereby the restructuring programme shall lapse unless the general meeting of the Company has not resolved on and implemented a directed share

issue to unsecured creditors of the company participating in the conversion within three (3) months of the affirmed restructuring programme having gained legal force.

By converting restructuring debt to shares in the Company, a restructuring creditor has the opportunity to benefit from a possible increase in the share price and to sell his holdings on the stock exchange, thus settling his restructuring claim.

All of Company's unsecured creditors, excluding disputed debts and debts whose basis or amount is conditional or uncertain, are entitled to convert their adjusted claims into shares of the Company at a ratio of [REDACTED]. The conversion ratio takes into account the fact that unsecured debts are cut by 90 % before conversion. The conversion ratio corresponds to a subscription price of [REDACTED] for the original restructuring debt. Should the conversion rate lead to a fraction, the amount of shares issued to a creditor shall be rounded down to the nearest integer.

The amount of unsecured debt entitled to conversion is approximately EUR 15.1 million. In case all the unsecured debt is converted into shares, the total number of new shares will be approximately [REDACTED] i.e. [REDACTED] of the total share capital of the Company. Thus, the conversion right included in the restructuring programme may dilute the shareholder's shareholding to a maximum of [REDACTED] of the current shareholding.

Creditors electing to exercise their right to convert their receivables to shares of the Company shall give an irrevocable conversion undertaking to the Company within two (2) weeks from the date of the affirmation of the restructuring programme by the District Court. A form for the undertaking is included as Appendix 20.1 (confidential). The debt conversion is alternative to a monetary payment, whereby restructuring debts may not be partially converted.

Duration of the Restructuring Programme

The duration of the restructuring programme is approximately five years. Under the restructuring programme, payments to creditors commence on 30 May 2025 and continue bi-yearly until 30 November 2029.

The restructuring programme ends when the Company has carried out all payments under the restructuring programme and when the supervisor has submitted his/her final account.

The restructuring programme lapses in its entirety if the Company is placed into bankruptcy. The District Court may order the restructuring programme to lapse in relation to a creditor if the Company has failed to fulfil its payment obligation towards the respective creditor and has not rectified its omission within a reasonable time period. Additionally, the programme may lapse by application of the supervisor should the Company fail to call a general meeting to decide on a directed share emission to creditors and to take all necessary measures to carry out the debt conversion within three (3) months of the restructuring programme having gained legal force.

Financing of the Restructuring Programme

The restructuring programme shall be financed by cash flow from the Company's business operations as well as additional financing. [REDACTED]

A cash flow forecast for the duration of the restructuring programme is included in Appendix 22 (confidential).

Creditor Groups and Voting

The administrator proposes that creditors are divided into the following groups when voting on the restructuring programme:

1. Secured creditors;
2. Creditors secured by a business mortgage;
3. Creditors of debts under public law; and
4. Other unsecured creditors

Creditors of debts of lowest priority are not entitled to vote.

The administrator proposes that creditors vote on a euro-per-vote basis.

A grouping and vote count of creditors is set out in Appendix 28.

Other Provisions

9.1

Conversion Obligation of Close Parties

As a prerequisite for the affirmation of the restructuring programme, the following close parties to the Company must undertake to fully convert their restructuring debts to shares of the Company:

- SCI-Finance Oy, restructuring debt EUR 360,283.70
- Savcor Oy, restructuring debt 147.209,30
- Iikka Savisalo, restructuring debt 50,385,51
- Hannu Savisalo, restructuring debt 36,666,63
- Tuukka Savisalo, restructuring debt 21,735.45

Obligation Concerning Management of the Company

Pursuant to the restructuring programme, the board of directors of the Company must critically assess the operative management of the Company as well as the composition of the board of directors. This assessment must be based on the management of a listed company as well as on good corporate governance. The board of directors of the Company must evaluate whether individuals who are close parties of the Company can be part of the management of the Company.

The general meeting of the Company is obligated to assess these matters within six (6) months from the affirmation of the restructuring programme. The supervisor of the restructuring programme may extend this deadline once by an additional six (6) months. Should these steps have not been taken within the deadline set in the restructuring programme or extended by the supervisor, the supervisor may request the District Court to order the restructuring programme to lapse.

Supervisor of the Restructuring Programme

The administrator proposes that a supervisor is appointed by the District Court to supervise the implementation of the restructuring programme once affirmed.

The duties of the supervisor include to supervise the repayment of the restructuring debts and the fulfilment of other obligations of the Company under the restructuring programme.
