## PLAYER AGREEMENT 2025-2026



## As a Rocket City Falcons Athlete:

- I will give my best effort in every practice and every game.
- I will be on time and present for every team event, or will communicate with the coach beforehand about conflicts or emergencies.
- I will respect the authority and the judgment of my coach.
- I will support and respect my teammates, opponents and the officials.
- I will communicate respectfully with my coach if I have concerns or questions.
- I will keep the locker room and practice areas neat and clean at home and away games.
- I will maintain a good academic status.
- I will practice good sportsmanship, representing RCF in a positive manner
- I recognize that my conduct during competition and on my own time impact my reputation, RCF's reputation, and
  my witness for Christ. As such, I commit to leading a Christian lifestyle in my language, dress, and
  personal/social relationships (including social media). I recognize that behavior judged to reflect poorly upon
  RCF may be answerable to the RCF Board of Directions with potential for suspension or removal from RCF
  athletics.

## As the parent of a RCF athlete:

- I will offer positive support for my child, the coaches, and the team at all athletic events.
- I will respect the authority and judgement of the RCF Board, Coaches, and the officials.
- I will discuss any concerns privately by phone or appointment with the coach first, then with the RCF president if necessary.
- I will teach and model good sportsmanship, representing RCF in a positive manner.
- I will pay the non-refundable participation fees associated with this sport in a timely manner.
- I will ensure that my child returns athletic equipment issued to them at the end of the season.
- I take responsibility to hold my child accountable to the RCF Athlete contract as outlined above.
- I recognize that my conduct at RCF athletic contests may impact my reputation, RCF's reputation, and my witness for Christ. As such, I commit to leading a Christian lifestyle in my language, dress, and interactions with officials/coaches/players. I recognize that behavior judged to reflect poorly upon RCF may be answerable to the RCF Board with potential for suspension or removal of my child from RCF athletics.

#### As a RCF Coach:

- I will respect the dignity of every athlete, parent, opposing team, and official.
- I will prepare for practice with an organized plan and be on time fore every event.
- I will communicate clear expectations to athletes and parents.
- I will teach and model good sportsmanship, representing RCF in a positive manner.
- I will do my very best to help each player grow as a player, a person, and a follower of Jesus Christ.
- I recognize that my conduct during competition and on my own time impact my reputation, RCF's reputation, the respect that my players have for me, and my witness for Christ. As such, I commit to leading a Christian lifestyle in my language, dress, interactions with players, parents, and officials, and personal/social relationships (including social media). I recognize that behavior judged to reflect poorly upon RCF may be answerable to the RCF Board with potential for suspension or removal from coaching RCF athletics.

**Dress Code:** Our organization has boys and girls teams and has families with different views of acceptable dress. Our goal is to provide a safe environment for our families along with abiding by league/conference rules. In accordance with those goals, we have a simple goal of modesty in how we dress for practice and while at games.

# **Practice and Game Day Attire:**

Athletes must not wear apparel or logos/slogans that contradict Christian values. All jewelry, including watches, necklaces, and piercings must be removed during practice and games. Athletes must wear all supplied practice or game uniform supplied. Any form fitting attire (i.e spandex, compression, etc) must be worn under shorts or tops must be worn under loose fitting apparel. All undergarments must be concealed. Sleeveless shirts may be worn as long as the armholes are small enough to cover undergarments. T-shirts must cover midriff.

Athletes are expected to wear warmups on game day in a respectful manner. Clothing worn under the uniform that is visible must be the same color as the uniform.

# Disciplinary Actions in Response to Violation of Athletic Agreement and Dress Code:

The Coach will handle issues calling for disciplinary action for violation of Athletic Agreement and/or dress code. If a player and/or parent/guardian is in violation of the Athletic Agreement/Dress Code the following will happen.

- Athlete or Parent/Guardian will receive warning.
- Athlete may be required to sit out a portion or all of game.
- Athlete may be suspended from play for multiple games. If Athlete is suspended for entire game they will still be required to report to the sidelines with his or her team.

### **Plausible Conduct Violations:**

- Being absent or late for practice or game without a timely and acceptable justification
- Derogatory comments, gestures, or attitude toward teammates, coaches, officials, or opposing team
- Disrespects authority or judgment of coaches or officials
- Unsportsmanlike conduct, such as taunting, strutting, celebration of oneself, standing over fallen opponent, booing and responding aggressively or bad tempered to official decisions
- Violence towards players, coaches, refs, fans including shoving, pushing, hitting
- Substance use/abuse including drinking, smoking, vaping
