AMENDMENT TO DECLARATION OF CONDOMINUM OF CANTERBURY F, A CONDOMINIUM

The original Declaration of Condominium of Canterbury F Condominium is recorded in Official Records Book 2137 at Page 1472 of the Public Records of Palm Beach County, Florida.

As used herein, words <u>underlined</u> are added and words hyphened through are deleted.

Item 1: Article XI of the aforesaid Declaration titled "provisions Relating to Sale or Rental or Other Alienation or Mortgaging of Condominium Units" is proposed to be amended by adding the following paragraph:

As of the date of this amendment, no Owner shall lease his or her Unit for the first year of ownership. The timeframe shall be measured from the recording of the deed or other instrument transferring title to the lot. The foregoing shall apply whether the agreement is a lease, rental or license agreement

Item 2: Article VII of the aforesaid Declaration titled "Method of Amendment Declaration" is proposed to be amended as follows:

This Declaration may be amended at any regular or special meeting of the unit owners of this Condominium, called and convened in accordance with the By-Laws, by the affirmative vote of Voting Members casting not less than fifty-one percent (51%) of those present in person or proxy provided a quorum is present. This Declaration may also be amended upon a vote of the Members by written consent in lieu of a meeting if a) the Association receives enough written consents from Members to constitute a quorum of the Members if a meeting was held; and, b) fifty-one percent (51%) of the total number of consents received approve the amendment.
