### Interpretation:

This dog carries one copy of  $\mathbf{A}^{\mathbf{y}}$  and one copy of  $\mathbf{a}^{\mathbf{t}}$  which results in a sable/fawn coat color. However, this dog's coat color is also dependent on the E, K, and B genes. The sable/fawn coat color is only expressed if the dog is also E/E or E/e at the E locus and  $\mathbf{k}^{\mathbf{y}}/\mathbf{k}^{\mathbf{y}}$  at the K locus which allows for agouti gene expression. This dog will pass on  $\mathbf{A}^{\mathbf{y}}$  to 50% of its offspring and  $\mathbf{a}^{\mathbf{t}}$  to 50% of its offspring.
