WAIVER AND RELEASE OF LIABILITY FORM

NOTE: THIS FORM MUST BE READ AND SIGNED BEFORE THE PARTICIPANT IS PERMITTED TO TAKE PART IN ANY EVENT SESSIONS. BY SIGNING THIS AGREEMENT, THE PARTICIPANT AFFIRMS HAVING READ IT.

1. I, the undersigned, as the parent or legal guardian of the child named below, do hereby give my full consent and approval for my child to participate in baseball lessons, clinics, workouts, strength & agility training, and physical conditioning provided by the employees or volunteers of, and/or the independent contractors associated with **Georgia Elite Baseball Academy**. I also give my permission for my child to participate (if selected) as a member of any teams sponsored or endorsed by **Georgia Elite Baseball Academy**.

2. I understand that by its very nature, the act of training and playing baseball along with but not limited to, weather conditions, travel and playing conditions can be hazardous. I also recognize that these risks include bodily injury, including paralysis, dismemberment, disability and death. While particular rules of the sport, skills, equipment, and personal discipline may reduce this risk, THIS RISK OF SERIOUS INJURY DOES EXIST, AS WELL AS THE RISK OF DAMAGE TO OR LOSS OF PROPERTY.

I agree that in consideration for the right to allow my child to participate in the activities described above and/or participate as a member of any team sponsored or endorsed by **Georgia Elite Baseball Academy**, and in consideration for permission to utilize **Georgia Elite Baseball Academy** Training facilities and play on the fields arranged for by **Georgia Elite Baseball Academy**:

1. On behalf of my child and myself, I voluntarily elect to accept and solely assume all risks of injury incurred or suffered by my child (a) while participating in the activities described above by the employees or volunteers of, and/or the independent contractors associated with **Georgia Elite Baseball Academy** (b) while practicing or playing as a member of an **Georgia Elite Baseball Academy** sponsored or endorsed team and (c) while on the **Georgia Elite Baseball Academy** premises and/or any fields or facilities arranged for by **Georgia Elite Baseball Academy** for practice or play.

2. I, FOR MYSELF, and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE, INDEMNIFY, HOLD HARMLESS and PROMISE NOT TO SUE **Georgia Elite Baseball Academy**, their officers, officials, volunteers, employees, agents, and/or other participants, sponsors, advertisers, independent contractors and, if applicable, the owners and lessors of premises used for the activity ("RELEASES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, and/or LOSS OR DAMAGE TO PERSON OR PROPERTY, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE, EXCEPT THAT WHICH IS THE RESULT OF GROSS NEGLIGENCE OR WANTON MISCONDUCT, to the fullest extent permitted by law.

I hereby certify that my child is fully capable of participating in the sport of baseball and the activities described above and that my child is healthy and has no physical or mental disabilities or infirmities that would restrict his or her full participation in these activities. I further agree on behalf of myself and my child named below, that I shall hold harmless and fully indemnify the parties hereby released from any and all claims, cause of action, damages and costs, including attorney fees, which may arise from any claim or cause of action brought by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.

I acknowledge that I have read (or have had read to me) each and every one of the provisions in this waiver, release of liability and indemnification agreement, that I understand each of the provisions in this agreement and that I agree to abide by them.
