**GENERAL INFORMATION:**

**Entries:** Trial organizers reserve the right to refuse any entry. If an exhibitor must be asked to leave the trial grounds for any reason, they will not be issued a refund.

**Entry Limits:** Handlers are limited to one dog per level per day.

**Waitlist:** If the trial fills a waitlist will be maintained. Should a space become available it will be offered to waitlist members in the order their entry was received.

**Confirmations:** Confirmation of entry will be emailed. Payment must be sent within 48 hours of receiving confirmation or your space will be released.

**Payment:** Etransfer to [dawggonegood@shaw.ca](mailto:dawggonegood@shaw.ca) **security question answer: wintergreen**

**Running order** will be determined by random draw, bitches in season who will run last.

**Refunds** will be given for withdrawals up to July 23, 2021 if the space can be filled from the waitlist. All refunds are subject to a processing fee of \$10.00 per entry.

**Awards** - qualifying ribbons presented per component; rosettes for placements (1st – 3rd) per component; rosettes for 1st – 3rd overall. SDDA New Title rosettes for new amateur titles.

**No Shows** – competitors not present at the time of their level briefing who have not made contact with the trial chair or trial secretary to give notice. No show spaces will be made available to those who showed up for onsite entries.

**General Rules:** Competitors, through the submission of their entries, acknowledge they know the Rules and Regulations. See Master Rule Book on the SDDA web site [www.sportingdetectiondogs.ca](http://www.sportingdetectiondogs.ca) to familiarize yourself with all rules.

Dogs must be under control at all times. Please keep barking to a minimum, pick up after your dogs promptly and note that your dog **MUST** be on leash when not crated or in the search areas. **Training and/or unofficial use of odour is not permitted on the trial grounds.**

**Refreshments** – There are many restaurants within minutes of the trial location.

**Crating** – There is no indoor benching. Be prepared to bench from your vehicle.

**Accommodations** – There are many pet friendly hotels within a short drive of the trial location.
