Monthly Status Report

Compliance

Drinking Water/OEHS

- March water quality samples completed, and Monthly Operational Report submitted without issue.
- Violation from Aug MOR for chlorine and turbidity paperwork, PN will be drafted by QWS prior to 10/15/2025. Council to advise on timing.

Wastewater/DEP

- February compliance samples completed, monthly eDMR submitted
- Exceedance on ammonia nitrogen. Corrective action on treatment has been to increase dosage of Biojet 7, will resample second week of March.
- Reminder that all spills should be reported to the DEP hotline (i.e. during rain events, etc.)

Operations

Drinking Water Plant

- The plant hours have increased since Friday the 4th of April. We are up from 10hrs of pumping to 14hrs. There must be a leak somewhere in the system
- After follow-up with electrician (Spiker), he will not be able to provide estimate for repair of contacts on high service pump #2 (initial quote for replacement too high). Repair parts are not able to be sourced. Need council to direct next steps.
- The motor on air compressor #2 went out. We have a new spare motor at the plant. We have scheduled to replace the motor 4/14/2025.
- There is a new focus from the state on enforcing fluoride levels for plants that add fluoride. With the higher level of hardness in the water, I have requested to start using Hydrofluorosilicic Acid instead of Sodium Fluoride to the water. This will help us maintain the required level and stay in compliance.

Wastewater Plant

- Replace missing power box safety switches for upper lagoon aeration update. Spiker assessed the boxes He
 said it might be best to switch out the boxes as starters need replaced. We could submit our plan to the DEP.
- Ridge vent on chemical feed building was blown off has been repaired.
- Mixers for lagoon need repair: One in Chamber 1, One in Chamber 3. Starters are bad for two of the mixers. The other mixer has a bad motor. We plan to have our operator trouble shoot them 4/14/2025.
- Currently seeking vendors to begin pricing process for repair of rubber pond liners (cited last DEP visit).

Other Items & Information



- Backflow PM Initial letters were mailed to customers mid-February. 20 businesses need to install devices by June 2025. 1 business needs to submit test results on an existing device by 04/15.
- Sedimentation basin sludge removal Town approved putting out for bids at Nov meeting. ON HOLD due to weather.
