Nineteen individuals attended a task force forum to discuss formation of a North Dakota State Genealogical Society. The three hour meeting was held on June 26, 1995 at the North Dakota Heritage Center in Bismarck. An initial welcome was given by Gerald Newborg. Facilitators for the meeting were John Mogren and Jacki Keck.

The Task Force identified four major areas of concern for genealogists in the State. These included the following:

- □ REPOSITORY (storage concerns)
- ☐ CLEARING HOUSE (resources, indexes)
- □ NETWORKING (exchanging information)
- LEGISLATION
