"City News for Sierra Bonita" By Councilman Fred Strong

The city is moving ahead diligently on many fronts while also irritating people on some things.

Transportation costs and availability are high on the list of currently important items for most of our citizens. Road conditions and availability are among those. We are working diligently to fix roads in poor maintenance, repair or that are damaged by Mother Nature. That costs money to do and we are doing so as quickly as is safe and fiscally responsible as possible. It is a bit frustrating when people who want the work done get irritated by the inconvenience caused by our efforts to do so.

In Sierra Bonita the City is working diligently through contracted services and our own staff to repair or replace nearly every water service in the area. This usually requires digging up areas of the street and hours or days of inconvenience. However, that must be done before we can put new asphalt down on our aging roads. We expect to have this completed by the end of the year and then proceed with the paving.

Somewhat the same thing is affecting the replacement of Commerce Way with a whole new traffic area of the road. We are not replacing the parking areas with new paving. The preliminary utility work for that project is also expected to be done before the end of the year.

Downtown parking fees have, once again, been approved by three of the five members of the Council not including your two Eastside Councilmembers (Bausch and myself). However, an effort is being mounted by opponents to put a referendum on November's ballot to remove that ordinance from the books and return to free parking or some other form of parking control Downtown. If the petition gets enough signatures the payments will be put on hold until after the election.

People liked the City Park lights Downtown at Christmas so much that we are continuing a lower key amount of them year-round beginning in a month or two.

In the economic development area, our efforts to diversify our economy is moving ahead in the airport area with Federal approvals being sought where required to move ahead. My trip, on behalf of the city, to Washington, D.C. in March will address that among other things regarding better funding for our infrastructure and transportation.

I'll try to tell you more at the Annual Meeting in March.
