
## Background

- Phase 2 of 3











# Water System Improvements



#### Water main

- Replacement of old cast iron critical water supply main line and upsize
- New gate valves and hydrants

#### Water services

- Replace public portion of all services
- Private lead service line replacements
  - Under separate contract one time exception
  - Anticipated installation late 2024- early to mid-2025
  - Filtration pitchers will be provided
- Ordinance 3043 makes the replacement of all public and private lead service lines mandatory

# Water System Improvements



#### 2024-2025 LEAD SERVICE LINE REPLACEMENT PROJECT

- The Village's Lead Service Line (LSL) Replacement Program outlines financial assistance for the replacement of private (customer) lead service lines:
  - Properties in Village LSL project areas will be eligible for financial assistance of up to 50% of the cost of the replacement of the private service funded by the Shorewood Water
  - Remaining costs will be the responsibility of the property owner:
    - 0% loan repaid in 12 equal installments on the 12 utility bills following replacement (3 years)
    - No prepayment penalty
    - · Past due installments may be placed on the tax roll





# Interim Lead Service Line Reconnections



- May be required if existing water services are damaged prior to water main replacement (48-inch relief sewer crossings)
- Existing water service will be cut and reconnected
- Village to provide water filter pitchers for resident use to address potential short-term elevated lead water levels
- Lead water services will be replaced under a separate project in late 2024 – early 2025



### Relief and Combined Sewer Improvements



- Relief sewer
  - 48-inch relief sewer on Downer
  - One diversion structure
- Combined sewer
  - Replacement of combined sewer mains on Downer and Newton
  - Reconnect existing sanitary laterals to new mains
- Inlet and catch basin replacement





# Tree Replacement



### Conflicting and Ash Tree Replacement

- Tree removal includes those conflicting with the installation of the proposed utilities and roadway on North Downer Avenue and East Newton Avenue (11 trees)
  - The 11 trees are isolated tree removals in conflict with utilities, service laterals, or curb and gutter
  - Additional tree removal and replacement may be needed if conflicts can't be avoided and will be a field determination
- Per the Village's Ash Replacement Program, ash trees will be removed and replaced
  - 17 ash trees in poor condition to be removed and replaced
  - All remaining trees to be treated for EAB under Village's current injection program
- Trees will be "aggressively" pruned by Shorewood forestry crews to reduce potential conflicts with large construction equipme

### Road Reconstruction



- New concrete curb and gutter
- New driveway approaches and carriage walks
- New pedestrian curb ramps with Americans with Disabilities Act (ADA) detectable warning fields
- Asphalt street
- Parking removed from west side of roadway to accommodate bike lanes
- Curb extensions with biofiltration devices at NW Shorewood and SE Menlo intersections
- Landscape restoration with sod
- New lighting and signage





# **Driveway Aprons**




- All driveway aprons in the project limits will be removed and replaced
- After removal, driveway aprons will be filled with gravel by the end of the day to preserve access
- Driveway aprons will match the width of existing driveway at the back of walk and flare 2 feet
- 24 to 48 hours notice given prior to driveway closure for curb and gutter and driveway installation
- No access to driveway during the installation of curb and gutter and replacement of driveway aprons – approximately 10 to 14 days.
  - EV owners should make plans for alternative charging locations during this access interruption
- On-street overnight parking permits will be hand delivered



### Traffic Detour



- North Downer Avenue traffic will be detoured to North Maryland Avenue for the entire project duration
- Per MCTS, bus stops on Downer will be taken out of service. Bus riders will use North Oakland Avenue bus stops
- WisDOT's Lake Drive project (Edgewood south to Kenwood) will begin July 2024 and will include a detour





### Traffic Closures



- North Downer Avenue and East Newton Avenue will be closed to traffic. Homeowner access within the project limits will be maintained.
- Hard closures will be located at Capitol and Edgewood. No access will be allowed at these intersections.
- Residents should review weekly notifications for access route to their property
- Hard closure at the north end of Ridgefield during the WisDOT detour to limit detoured traffic from entering





# Resident Impacts

Shorewood

- Construction starting at the intersection of Edgewood and Downer
- Work hours 7 AM to 6PM, Monday-Friday
- Written notice of driveway installation, roadway paving, road closures and sod care
- A minimum 48-hour notice for any non-emergency water shut-offs will be provided
- Mail and delivery trucks will have access to properties
- Contractor will allow truck access for refuse, recycling and yard waste pickup

#### **Project Timeline**

Feb./Mar. - Construction begins with water main installation May - Relief and combined sewer installation begins June - Private water service installation begins Aug. - Combined sewer and water completed Sep./Oct. - Paving begins





# Resident Impacts

Shorewood

- Vibratory compaction to backfill trenches will cause vibration in homes
- Heavy equipment is noisy
- Trench depth will reach over 20-feet deep in some locations
- Sidewalks will be closed during portions of construction
- Dust control will be performed
- Temporary street light outages will occur




# Typical Construction Sequencing



Example installation and schedule sequence for a homeowner located on the project

- Relief Sewer (April)
- Combined Sewer (June)
- Water Main (July)
- Service Laterals (August )
- Storm Sewer (September)
- Sidewalk/Driveways (October)
- Curb and Gutter (October)
- Roadway (November)
- Topsoil/Sod (November)

Project Completion	June 30, 2025






