What would you do for LGBTQ+ people in your political area?

The biggest thing that I can do for the LGBTQ+ community in Union County is to listen. I'm not a member of the community but I am and will always be a strong ally. I pledge to engage with and amplify the voices of LGBTQ+ folks in the county and use their experiences, opinions, and guidance in my actions both in office and in my daily life.

What would you do to for LGBTQ students?

As a County Commissioner I wouldn't have a lot of oversight of what the school board does in regards to specific actions. However, I would absolutely go to war with them, including filing discrimination lawsuits and withholding funding, if they continue to degrade the LGBTQ+ community in the classroom. I will work to ensure that their policies don't harm and instead uplift LGBTQ+ students so that they feel safe and comfortable in their place of education. Additionally, though outside the classroom, I'd work to reinstate all equality programs at the libraries

in the county. All Union County residents deserve representation and programs that promote equality benefit the whole county.

How would you vote on policies or laws regarding books in schools with LGBTQ+ characters?

Schools have a responsibility to educate students. As I have interacted with the LGBTQ+ community more and more, I have learned how important representation is for them and additionally, for those who aren't a part of the community in order to further educate all children on the LGBTQ+ community. Currently our school board, mostly for political posturing, has been trying to marginalize different communities in Union County. This will not stand if I'm elected. As I mentioned above, I'd absolutely be willing to go to war with the school board over this. I don't think that there are two sides to this issue; we shouldn't negotiate with folks who discriminate.

Please explain your answer.

I was recently trying to get some insight into the LGBTQ+ community and wound up on the website for The Trevor Project. As the page opened a pop-up informed me that I could exit quickly by hitting "esc" three times. It took me a second to realize why the site would have a quick hide action. But, to answer the question above, I'm going to quote the front page of that site:

"LGBTQ youth are not inherently prone to suicide risk because of their sexual orientation or gender identity but rather placed at higher risk because of how they are mistreated and stigmatized in society."

Children who are starting to realize that they may not get support at home will need to find support in other places. This includes their schools. Ensuring safety from mandatory reporting and other laws that force students to feel unsafe and live in fear of being outed is one way that we can prevent harm to students within the LGBTQ+ community.

How would you vote on policies or laws regarding books in schools with LGBTQ+ characters?

Books that contain LGBTQ+ characters are no different than any other book. Passing laws, or allowing schools to pass policies, that are discriminatory should never be allowed. As mentioned above, a school board who tries to enact such deplorable policies will have a fight on their hands.
