When my children were growing up, I made sure to provide them with opportunities to participate in comprehensive human sexuality education. I was determined that they would be vastly better prepared for adulthood than I was. To this end, I taught this curriculum at two levels at my church. This curriculum is called Our Whole Lives and provides instruction at 5 levels, kindergarten, 5th grade, middle school, high school and adulthood. All instruction is age appropriate. To be trained to teach this curriculum was an amazing opportunity that I will be forever grateful for. To learn about the rich diversity of gender, gender expression, sexuality and sexual expression was transformative for me. I have read, attended focus groups, discussion groups, seminars, parties and social gatherings all geared towards a better understanding of the complex nature of human beings. Such experiences build a base of knowledge and reduce fear of the unknown. I have learned to see all people for who they tell me they are and to be welcoming and to make space for a perspective that is not my own.
