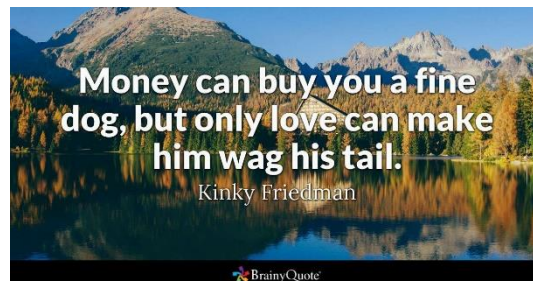

AMENDMENTS TO WHWTCNE CONSTITUTION, BY-LAWS, AND CODE OF ETHICS, REVISED 2018 PASSES.



The proposed changes to our By-Laws was voted upon and unanimously passed at our general meeting on April 8, 2018. According to Article VIII, Section 2, the Constitution and By-Laws “*may be amended by a 20% quorum with a 75% affirmative vote by the members in attendance or through a valid absentee ballot and voted on at the Club’s annual meeting or at any regular meeting.*” Our club has a total of 77 members, of which 54 have full membership with voting rights at the time of voting. Eleven voting members were needed for a quorum at our banquet, with 8 affirmative/negatives votes needed to pass/decline the changes. Nineteen voting members were in attendance; four absentee ballots were received by the corresponding secretary. All 23 voting members chose to approve the proposed changes.

The following are the changes passed:

★ Article II Membership, Section 1 Eligibility

The two types of membership (Full and Limited) have been removed. Membership is open to all persons, and all members now have voting privileges and all rights offered by membership. There are now only two types of Membership: Individual and Joint.

★ Section 4 – Termination of Membership Section C

The one meeting attendance requirement has been deleted. Members retain their membership, provided they are members in good standing, whether or not they attend a meeting in a given year.

★ General wording has been changed throughout the By-Laws and Code of Ethics documents

Wherever the word “shall” appears, it has been changed to “should.”

The words “Full Member” and “Full Membership” have been changed to “member” and “membership” respectively.

“Additional nominations may be made at the June meeting by any voting member in attendance, provided that the person so nominated does not decline when his/her name is proposed, and provided further that if the proposed candidate is not in attendance at this meeting, the proposer shall present to the Corresponding Secretary a written statement from the proposed candidate signifying his/her willingness to be a candidate. No person may be a candidate for more than one position, and the additional nominations which are provided for herein may be made only from among those voting members who have not accepted a nomination of the Nominating Committee. If no valid additional nominations are received by the Corresponding Secretary, the Nominating Committee's slate shall be declared elected, and no balloting will be required.”

Training Humans 101

For centuries, humans have felt it was their duty to train a dog capitulate to their every whim. Poor misguided souls. The moment a dog becomes a part of the human pack, you must get right on it and start training them. As an adult dog, you most likely have had some experience along these lines. Puppies, however, only know the important lessons taught to them by their dam. So, right off the bat, a puppy is at a slight disadvantage. But as the puppy matures, it becomes apparent to them that humans are not too smart. Getting them to understand our language, vocal and otherwise, is frustrating. But hang in there! It can be done with a lot of patience.

It seems that their first step is to train us where to do our “business.” That’s okay as we like to live in a clean house. But their repetitive nagging gets on one’s nerves! We’ve been shown where to go outside, so why keep shoving us out that door every fifteen minutes! And then get upset when we don’t pee or poop! As dogs we are well aware of our bodily functions. We certainly are smart enough to alert the human to the “call of nature.” But here’s the kicker. Is the human paying attention? Left alone all day, as some of my pals are, they don’t have anyone to alert, or the human is not paying attention! Ya, it’s true. We can “hold it” for a long time. However, after 10-12 hours, who doesn’t have to pee? So, an “accident” happens. Whose fault is that? Hours later, we have no clue as to what the “words” being yelled at us mean. The best you can do is look remorseful. Works every time! The human cleans up the “accident” and then is hugging you! Confusing? Yes! The lesson learned here by the human is to not let you stay alone too long in the house! Geez! What a no-brainer!

Dogs quickly learn the sound of the word “walk” because we are smart. Since we associate the sound of that word, we know that it means going outside for a stroll. Surveying our territory is part of our job to scare off any intruders.....squirrels being the biggest offenders. This is when you use your outdoor “words” by barking loudly. Some humans just don’t get it and think that they need to help us. So, they yell, their version of barking, right along with us. The dog barks, the human yells. Okay, we’re doing the right thing.

You have to study your human, so you will know the best approach to train them. Two modalities (see? I know big words!) at your disposal and you will need both of them to be successful. One is using your words. Because a human doesn’t understand our language, you have to teach them. It’s like you have learned the sounds of their words and what they mean, so they have to learn the sound of your barks and what they mean. Loud barking indicates an “intruder” is at the door or lurking around in your yard. Most humans do not like loud barking and will go and investigate. DUH! Isn’t that the point? Once you perfect the art of whining, this will go a long way in training the human exactly to what you want. But be careful! The second modality is your body language. There are a number of ways you can train your human just by looks and nonverbal body actions to get what you want. Here are a couple of examples: standing over your empty water dish. What human would not understand that a refill is called for and you are thirsty? Blows one's mind! You are in need of some fun exercise. Drop a ball or other favorite toy at their feet and stare at it. If the human doesn't respond, wag your tail and add a little yip. That should do it! If not, continue this exercise several times until the human "gets it" and will throw the ball/toy for you to retrieve. Now it is important to keep this game up until you have had enough, not the human who seems to tire more quickly. Just "hang in" there!

Most of us have learned to associate the sound of the word "ride" with one or two things; we are being taken in the family car for a delightful adventure...OR...nine times out of ten...it's off to the vet's office! DUH? You're not feeling sick! You can express your unhappiness at being at the vet's office by whining and shaking. Give it up! It's evitable so why fight it! Your best defense is to make friends with the vet. This will, undoubtedly, make your human very proud. Being poked and prodded is not much to your liking but restrain yourself from becoming obnoxious. This thing called a "Wellness Check-up" is ridiculous! You feel fine! However, you have to understand that humans, in their infinite wisdom, need to know that we are healthy. Only if we had the capability of dragging them off to a human doctor to be poked and prodded would they really understand how this "Wellness Check-up" is unnecessary!

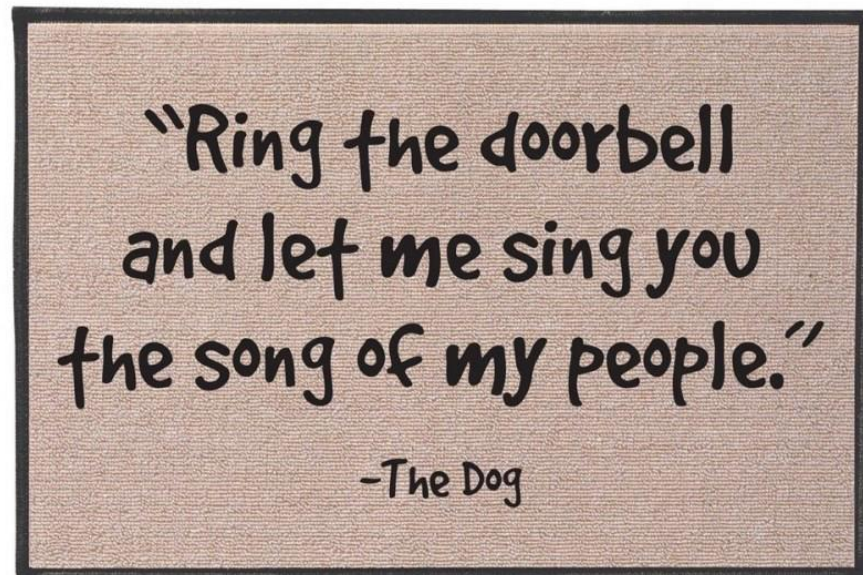
Unfortunately, we have very little control over what we are fed. Most dog foods on the market are palatable. However, you are at the mercy of the human to select a food that is absolutely yummy! If, per chance, what is offered in your food bowl is not particularly appealing, walk away! Nothing drives a human more nuts than when you refuse to eat a meal! Their first reaction is that you don't feel well. Ridiculous! You have given the food a sniff. It smells awful! You take a tentative bite. YUCK! It tastes even worse than it smells! Then comes the cajoling to get you to eat this horrible stuff. Nope! Stand your ground! Eventually...short of insisting that the human eat this awful stuff.... they capitulate and offer you some human food, which is always very tasty, but again, will make you fat! So, the hunt goes on for them to find a yummy kibble that you like. Just be patient! It will happen!

Sleeping accommodations within the pact is another whole issue. A nice cozy dog bed is fine and many of my pals like their beds. But wouldn't it be better to sleep on that huge, soft bed with your humans? You know the one! The bed where you jump up for a snooze when they're not home. It's easy to train them let you do this. At bed time, pace the floor and whine. Go into their bedroom and scratch at the side of the bed or.... if the bed isn't too high....simply jump up on the bed. At this point, cuddling and kissing the humans goes a long way. It goes without saying that in order to be a faithful companion to our humans and to successfully live in their world we must train them! After all, we are smarter than any human. Don't be fooled by all their accolades and forth coming with lots of toys for your enjoyment. Ya, this is very nice and what you expect from your human. But, just remember, YOU are in charge of them!! Okay. It all comes down to a little take and give. And that makes for a very good long-lasting relationship.

My name is Jake. I'm a West Highland White Terrier. I'm...oh never mind my age. Suffice to say I've been "around the barrel" several times and I know what I am talking about as I was a rescue dog. My human has been very well trained by my predecessors over the years.... thus making my job very easy. She knows my body language and as I do hers as well.
