**Sue Winter:** Well, I'm here to apply for a kennel permit. I've always had four dogs. All my dogs are licensed. I do have my daughter's dogs with me once in a while. She's still in college. I have her dogs' licenses from the Town of Seneca Falls, if you want to see them.

**Dennis Grabb:** No, it's not necessary.

**Sue Winter:** No, okay. I have her two along with my three. Unfortunately, my oldest passed away last week. So, I only have three now. Unless a pup comes along that needs rescuing, which is most of what my animals are, I'd like to keep it at three, but still just in case I do get a fourth one, I just want to be in compliance. I never knew when I licensed them with the Town that three was the limit. I licensed all four, nobody said anything. I had a 6' chain link fence put in specifically for my animals a couple of years ago. With the exception of about 50 feet from the road my entire yard is fenced in. I keep the gates locked.
