

* Avg full charge time: 5-8 hours

Level 3 - Charging Uses – 480 Volt AC to DC current

* Ave full charge time: 15–60 minutes

* There are four requirements to be eligible for the program:

- 1. Must install 2 or more charging plugs can be a combination of Level 2 & 3 plugs.
- 2. Charging stations must be networked and charging data uploaded to NYPA quarterly.
- 3. Charging stations must be on a commercial electric meter.
- 4. Stations hardware capable for ISO 15118-2 and -20, effective 12/16/23 & achieve software conformance with ISO 15118, effective 11/16/24.
- The program helps pay for the infrastructure costs (labor & material) to bring power to the base of the charging stations. It does not pay for the cost of the charging station itself or the networking.
- The program can only be applied to once per electric utility address. Additional incentives are available to future proof projects to lower the future expense of adding additional charging stations.

Privately located: are eligible for up to 50% - Gated parking lots, service bays, private clubs.

<u>Publicly located</u>: are eligible up to 90% - Open parking lots, restaurants, hotels, stores.

Only Multi-Unit dwellings in DAC areas: are eligible up to 100% - Apartment building of 5 + units.

Level-2 Chargers - Program Incentive Calculations:

- Projects qualifying for 100% incentive level will have a baseline cost of \$7,000 per plug.
