I spent some time going over your window project this morning and I just received numbers back from my supplier. Below I have outlined the scope of work and project total.

- remove and replace two windows (38" x 68") and one exterior door (30" x 80") on front of house facing the road (south), siding will need to be removed and reinstalled, new Azek trim will be installed in place of existing metal Window cost: \$450 each (double hung, half screen, argon)

 Door cost: \$405
- remove and replace one exterior door (32" x 80") on back porch (north), siding may need to be removed to install white J-channel up to new Azek trim Door cost: \$405
- remove and replace both existing kitchen windows with large casement window (64" x 36"), siding may need to be partially removed to install white J-channel up to new Azek trim Window cost: \$975
- remove and replace one exterior door (32" x 80") on east side porch, remove and replace one window (32" x 64"), siding may need to be partially removed to install white J-channel up to new Azek trim Door cost: \$460 Window cost: \$405


