Meeting was called to order by Deputy Supervisor Chris Tertinek. All Board Members were present. Supervisor Scott Johnson was absent.

Public Speaker:

Adam Breen-Alternative Technology (Network Rebuild Quote)

Adam Breen with Alternative Technology (Official Town of Sodus IT Specialist) discussed with the Sodus Town Board the intermittent power outages the Sodus municipal offices have regarding the UPS backup and the internal server. The server currently houses a large amount of data for the Town municipal offices. Since it was replaced last year, the UPS battery backup for this server cannot currently hold the power for this computer. Whenever the power goes out (even for a second) the server shuts down immediately. This is putting at risk the loss of data and the server itself being destroyed. With the uncontrollable power outages in the building, the solution would be to have a larger capacity UPS backup for the server. In addition, it was mentioned by Adam that a second UPS backup would be very helpful in the event the power surge or outage is more than a few minutes.

Adam discussed other issues with our technology that he sees in the municipal building and our technology set up currently. These are phases that can be worked overtime and are not an immediate concern. Adam submitted a Network Rebuild Plan into 5 separate phases. The first phase is the phase that needs to be addressed immediately. The Town Board will decide on this at our next regular town board meeting in October. (Note: Quotes of the 5 phases are listed behind the typed minutes in correspondence)
