### Covid-19 Guidelines as of 1/18/2022

The following information will be the Kid Central Covid-19 Guidelines. Please be aware, these guidelines are subject to change. For further information, please contact the center and speak with Gary Ziele.

### What happens if my child is exposed to a positive case at the center?

If a child in the center is exposed to a positive Covid-19 case, they will be asked to quarantine for 5 days from the date of exposure. You will be contacted by a member of Kid Central Child Care to specify the exposure date and the date in which your child may return to the center. We may or may not require a negative test for your child to return, based off the specific situation. An At-Home or a PCR test would suffice.

# What happens if a child at the center tests positive, but they have not been in direct contact with my child?

If your child has not been exposed, then your child may continue attending. We advise you to please monitor your child's health to be safe. We will also continue monitoring their health while at the center.

### What happens if my child tests positive for Covid-19?

If your child tests positive, please contact us immediately. You must also reach out to their doctor as soon as possible. They may return to the program after 7 days from the date the positive test was taken. They must also not have any symptoms when they return. If symptoms are still present, then the child must remain home for no less than 10 days from the date the test was taken or until symptoms are no longer showing. A doctor's note will not be required after these quarantines. However again, children may not have symptoms when they return.

# What happens if my child is exposed to a positive Covid case, but has already had Covid and recovered?

If your child has already tested positive for Covid-19 within 90-days, they will not be required to quarantine. However, if they begin to develop symptoms, they will be required to take either an At-Home Test or PCR before returning to the program. If the test results come back positive, they will need to quarantine for 7 days, starting from the date the test was given. They may return so long as symptoms are not present.

#### What happens if I or a family member tests positive for Covid-19?

If someone in the household tests positive, then your child may not return to the program until the family member's isolation is over. Your child will also need to take a covid test at the end of the isolation to confirm they are negative. This may be done with an At-Home or PCR Test. You will need to send us a picture of the At-Home test results or email us the test results given to you by their doctor.

## What happens if someone in the household must quarantine because they have been exposed?

Your child may still attend the program so long as they are isolated from the individual who is under quarantine, and so long as your child is not showing symptoms. If the person under quarantine begins showing symptoms or tests positive, please refer to the above situation.

#### Is tuition still due if my child must quarantine or tests positive?

Weekly tuition payments will be due regardless of the situations listed above.
