- 15. INFORMATION: Open Enrollment Michele discussed that Open Enrollment started last Monday and continues for 2 weeks. We will have space and will continue to accept students after the window closes. We currently have 85 Open Enrollment/Inter-district transfers signed up. We have 545 7th graders and anticipate 440 from our feeder schools. We need at least 30 more OE/IDT. Greater challenge is that last year, 53 students from our feeders did not come for various reason, including remaining in home school type programs. We continue to advertise, hold tours and encourage word of mouth. One drawback from feeders could be that PTSA meetings continue to be online and there are no activities on campus so parents may still feel disconnected. This all is just a sampling of the statewide issue of declining enrollment. Board members asked how to increase enrollment in the independent study program when prescribed.
