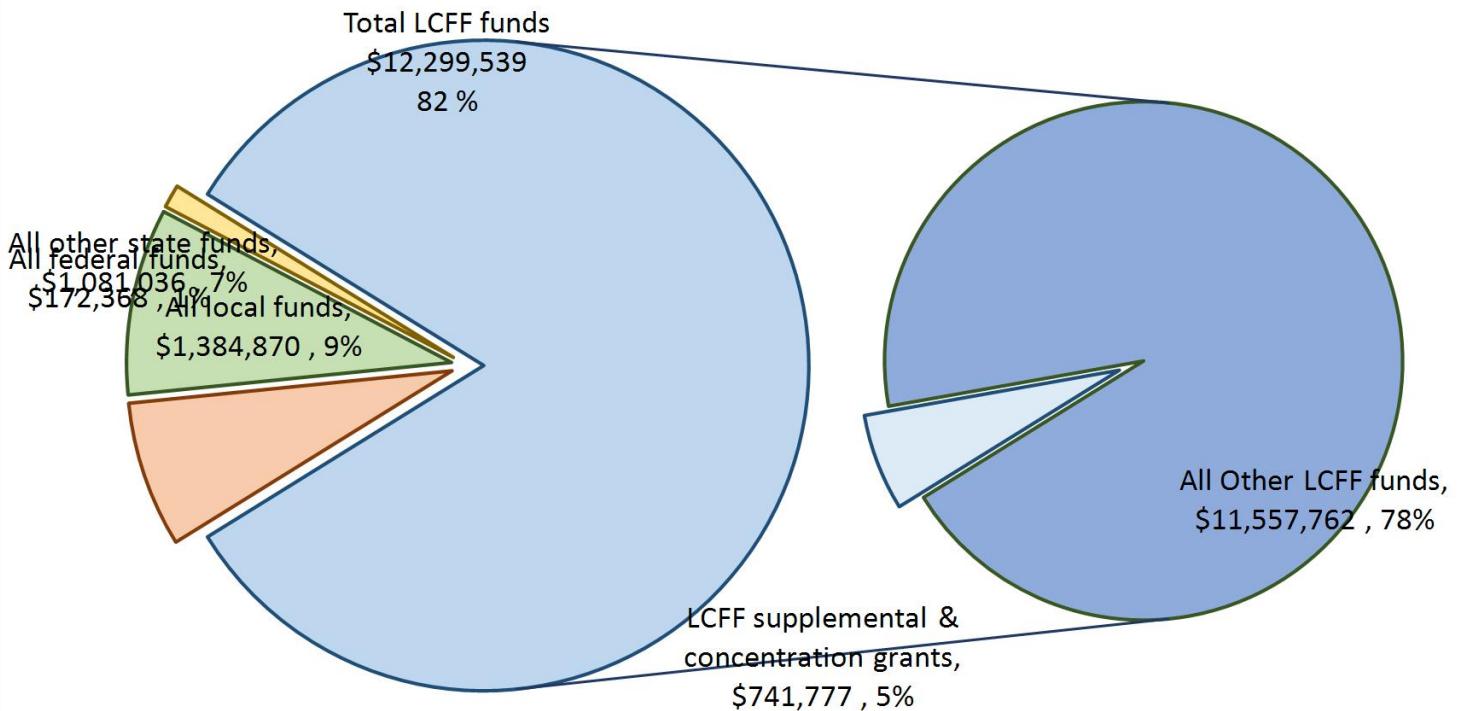

Projected Revenue by Fund Source

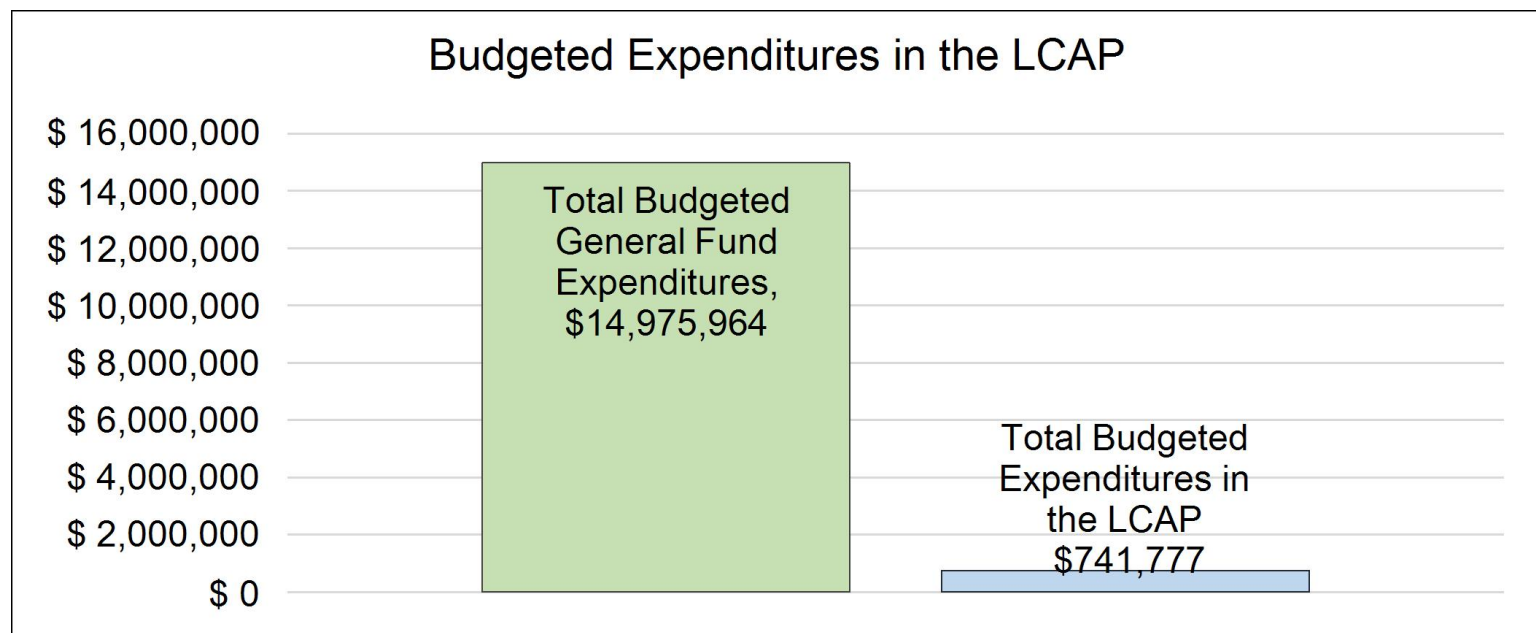


This chart shows the total general purpose revenue El Rancho Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for El Rancho Charter School is \$14,937,813, of which \$12,299,539 is Local Control Funding Formula (LCFF), \$1,081,036 is other state funds, \$1,384,870 is local funds, and \$172,368 is federal funds. Of the \$12,299,539 in LCFF Funds, \$741,777 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

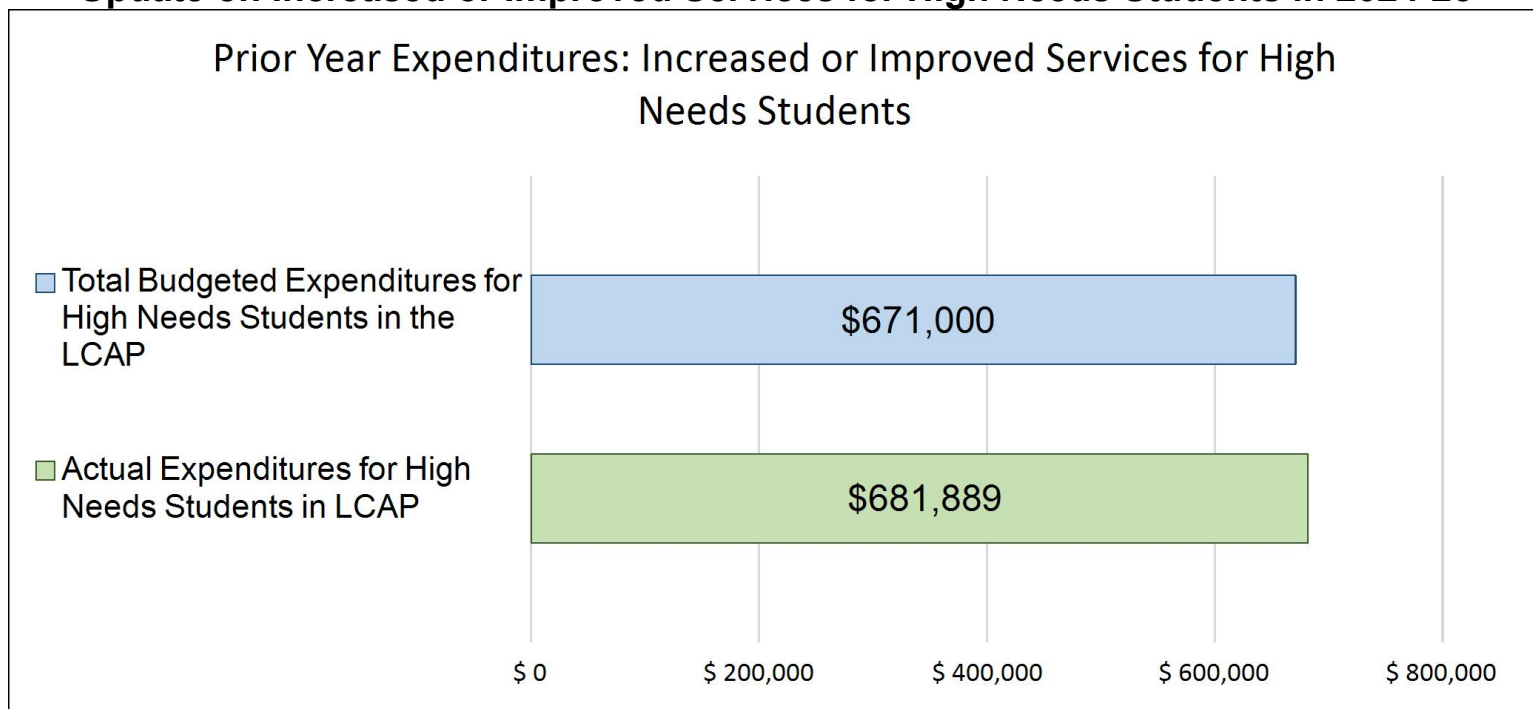

General Information

El Rancho Charter School serves just over 1,100 seventh and eighth grade students in Anaheim Hills, California. The mission of El Rancho is to “Maximize Every Student’s Learning and Personal Responsibility.” The quality of any program begins with high expectations. This is not just what is expected of the students, but what is expected of teachers, parents, classified employees, and administrators. School personnel understands it takes all of these entities to create student success both inside and outside of the classroom. In addition to a very solid curriculum focusing on the Common Core State Standards, El Rancho is proud to offer an extensive elective program. Students may select from a variety of courses in the fine arts, foreign language, as well as the practical arts. They may also choose band, guitar, orchestra, dance, art, woodshop, and technology classes. In addition, El Rancho is proud to offer an exemplary physical education program which incorporates the use of science, technology, engineering, and math into daily lessons. Through collaboration of the students, staff, parents, and community, the culture and atmosphere is one of support and accomplishment. In order to ensure all students reach their highest potential, we offer many supports and interventions to allow all students more time during the school day to reach their goals. We have multiple tiers of support which allow for all students to benefit. All students participate in the twice-a-week tutorial program. This has helped all students improve academically and allows time for them to master concepts that might have been left behind in the past. In addition, we provide after-school math academy and homework club so students can obtain help from teachers in various content areas. To support students in English and math, we offer two-period block classes with reduced class sizes, so students receive more individualized attention and have more time to learn and practice content material. Finally, for students who require intensive supports, we provide mandatory tutorial two days a week, have a check-in check-out system, offer an academic skills course, and these students have weekly meetings with their advisor. It is the goal of El Rancho Charter School to offer academic excellence to our families by providing flexibility through our charter and a continuous model of improvement. As the result of the balance of educational supports, elective choices, a quality physical education

program, and high academic results, along with social and emotional supports, collectively are the key to success. El Rancho is a single LEA and does not receive Equity Multiplier funding.

Reflections: Annual Performance

While El Rancho has focused on math and English and has made gains in each content area, we intend to maintain our commitment on maintaining/improving in these two academic areas. Analyzing results in both English and math, along with reviewing our interventions, has allowed us to focus on the needs of all our students. This analysis also allows us to continue our focus on particular areas of need for our students, including, EL students, long-term EL students, and low-income and foster youth. In addition, El Rancho has expanded our social and emotional supports to ensure all students have access to our resources. In reviewing El Rancho's Dashboard data, El Rancho was able maintain consistency through CAASPP testing and I-Ready level of performance in order to determine students outcomes. Our Dashboard indicators in 2024 reflect an overall performance in the Blue (highest) performance category in both ELA and Math. Out of the fourteen (14) student groups identified on the Dashboard, El Rancho has no student groups in the lowest performance level of academic achievement (English Language Arts and Math), no student groups in the lowest level in academic engagement (Chronic Absenteeism), and no student groups in the lowest performance level of conditions and climate (Suspensions). El Rancho continues to reflect on our practices yearly to ensure the provide the highest quality program possible.

Two surveys were provided to students, one at the end of Trimester 1, and the second after Trimester 2. In addition, the LCAP survey included input from students, parents, teachers, administrators, and staff to ensure proper supports and needs were being addressed.	Students were provided two surveys, one at the end of Trimester 1 and Trimester 2, to determine their connectedness to school. This included questions on how they connected to friends, teachers, and their elective choices. In addition, El Rancho consulted with teachers, administrators, staff, parents and students in the development of the LCAP by providing a more broad survey including academics, technology, and school connectedness (electives, after school sports/programs). The LCAP survey opened January 10, 2025 and closed February 28, 2025. It was sent to teachers, administrators, staff, parents, and students as well as posted on the El Rancho website. Based on the information gathered, the LCAP was developed with input from all groups.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

In an effort to support the needs of our students, two survey's were provided to gather information on their connectedness and safety at school. Questions regarding their class options, teacher support, and safety at school were asked. Of the students, staff and parents who responded to the LCAP survey, 71.8% said students prefer using technology as a resource. Platforms including Google Classroom, Edpuzzle, Peardeck, and Jamboard are some of the tools which continue to be utilized by teachers in their classrooms. Of those surveyed, 76.9% believe teachers are effectively using technology as an instructional resource. In the area of English Language Arts textbook and learning materials, 97.4% believe these materials meet the needs of all students. Of those surveyed, 94.9% believe the math textbooks or learning materials meet the needs of all students. Of those surveyed, 92.3% believe the science textbooks or learning materials meet the needs of all students. In the area of interventions and supports, 94.8% believe a double math period, tutorial, math academy, and homework club are beneficial academic supports. In addition, the all students have the opportunity to participate in engaging programs or activities such as robotics, lunch time games and activities, after school sports, various elective choices, garden gnomes, and chess.
