**17. INFORMATION: LCAP Mid-year update.** Michele explained that we reviewed recent assessments in focus areas of math and English. 7<sup>th</sup> grade math improved by 6% and 8<sup>th</sup> grade math improved by 7%. 7<sup>th</sup> grade English went down only 2% and 8<sup>th</sup> grade went up 3%. Overall, we are moving in the right direction towards our goals. Fran reported that spending to date has been according to the plan.

**18. INFORMATION: Governor's proposed budget and enrollment update.** Fran presented an overview of the governor's proposals for 25-26. She explained that there are no projected revenues outside of LCFF and that the COLA would be 2.43%. These base revenues would equate to \$11,422 per student. We are currently below expectations for enrollment but continuing to promote our school and accept open enrollment and inter-district transfer applications. She also stated that although

enrollment may be lower, it is not necessary at this time to make any changes in our program.
