TOPIC: PUBLIC HEARING: EL RANCHO CHARTER SCHOOL 2021-2024 LOCAL CONTROL AND ACCOUNTABILITY PLAN

DESCRIPTION: The Local Control and Accountability Plan (LCAP):

- The Local Control Funding Formula (LCFF) requires LEAs to engage their local stakeholders in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics. These results are documented in the LCAP.
- Based on performance across the state priorities and on indicators in the California School Dashboard, the LCAP demonstrates how budgetary resources are responding to student and community needs, addressing performance gaps and meeting our obligation to increase and/or improve services for foster youth, English learners and low-income students.
- El Rancho Charter School has chosen 3 Goals to address: Math, English and Social and Emotional Learning.

Plan Summary [2021-22]

General Information

A description of the LEA, its schools, and its students.

El Rancho Charter School serves 1150 seventh and eighth grade 7-8 students in Anaheim Hills, California. The mission at El Rancho is to “Maximize Every Student’s Learning and Personal Responsibility.” The quality of any program begins with high expectations. This is not just what is expected of the students, but what is expected of teachers, parents, classified employees, and administrators. School personnel are well aware that it takes all of these entities to create student success both in and outside of the classroom. In addition to a very solid curriculum focusing on the Common Core State Standards, El Rancho is proud to offer an extensive elective program. Students may select from a variety of courses in the fine arts, foreign languages as well as the practical arts. They may choose percussion, orchestra, dance, an array of art and technology classes, Spanish and additional courses like woodshop and home economics. In addition, El Rancho is proud to

offer an exemplary physical education program which incorporates the use of science, technology, engineering, and math into daily lessons. Through collaboration of the students, staff, parents, and community, the culture and atmosphere is one of support and accomplishment.

In order to ensure all students reach their highest potential, we offer many supports and interventions to allow all students more time during the school day to reach their goals. We have multiple tiers of support which allow for all students to benefit. All students participate in the twice-a-week tutorial program. This has helped all students improve academically and allows time for them to master concepts that might have been left behind in the past. In addition, we provide before-school and after-school math academy and homework club so students can obtain help from teachers in various content areas. To support students in English and math, we offer two-period blocks with reduced class sizes, so students receive more individualized attention and have more time to learn and practice content material. Finally, for students who require intensive supports, we provide mandatory tutorial four (4) days a week, have a check-in check-out system, offer an academic skills course, and these students have weekly meetings with their advisor. Although COVID has changed the programs this year, our intent is to return to the many interventions to support student learning and success.

It is the goal of El Rancho Charter School to offer academic excellence to our families by providing flexibility through our charter and a continuous model of improvement. As the result of the balance of educational supports, elective choices, a quality physical education program, and high academic results, along with social and emotional supports are the key to success.

Reflections: Successes

While El Rancho has focused on math and English and have made some gains in each content area, we intend to maintain our commitment on improving in these two academic areas. Analyzing results in both math and English along with reviewing our interventions has allowed us to focus on the needs of all of our students. This analysis also allows us to continue our focus on particular areas of need for our students with disabilities, EL, low-income and foster youth. In addition, El Rancho has expanded the need to expand the social and emotional needs of all students. El Rancho is committed to working through the Performance Index Review (PIR) process in ELA to support our special education students. During the 2019-2020 school year, El Rancho was able to increase our math performance to improve from the green band to the blue band. In ELA we were able to maintain our performance in the blue band. In the area of English Learner Progress, 66.7% are making progress towards English proficiency.

Reflections: Identified Need

Based on the California Dashboard, an area of improvement going into the 2019-2020 school year was to focus on our suspension rates. Looking deeper into the data, we found our special education students have our highest suspension rate. Our goal is to continue to provide other interventions to suspension. In looking at our ELA and math results, a focus will remain on our special education, EL and

socioeconomically disadvantaged students. During the 2020-2021 school year, while academic progress was a focus, El Rancho has also focused many of our efforts on the mental health of our students and staff. This will be a continued need moving into the 2021-2022 school year, as more students return to school from distance learning.

LCAP Highlights

During the 2019-2020 school year El Rancho was able to meet it's goals in both math and ELA by reaching the blue band in each subject area. In addition, we were able to increase our chronic absenteeism from the yellow band to the green band. While El Rancho has focused on math and English and have made some improvements, we intend to maintain our commitment on improving in these two academic areas. Analyzing results in both math and English along with reviewing our interventions has allowed us to focus on the needs of all of our students. This analysis also allows us to continue our focus on particular areas of need for our students with disabilities, EL, low-income and foster youth. In addition, during a year like no other, El Rancho has expanded our focus to the social and emotional needs of all students. We have created a website with expanded resources and extended counseling to all students to ensure their well-being is taken into consideration.

Several survey's have been provided throughout the 2020-2021 school year in order to determine the needs of students while distance learning, the return to school options, and continued support for students and staff. In addition to various student, staff and parent survey's, parent groups were also engaged in the process throughout the school year. Several meetings were held during the 2020-2021 school year to discuss priorities for the 2021-2024 LCAP.

A summary of the feedback provided by specific stakeholder groups.

Much of reopening El Rancho focused around school safety, cleaning procedures, and social distancing. Considering almost half of our students remained distance learning, it was important for students to see and work with their peers synchronously throughout the day. Approximately 65% of our families chose to return to in-person learning. There are approximately 206 students on campus on Monday and Tuesday and 264 on Wednesday and Thursday. Approximately 521 students chose to stay distance learning for the 2020-2021 school year. As a first tier intervention for both academics and social and emotional support, we have approximately 175 students on campus four days a week. This includes our special education, EL, and socio-economically disadvantaged students.

A description of the aspects of the LCAP that were influenced by specific stakeholder input.

Through the many stakeholder surveys, El Rancho staff determined the main areas in the success of the 2020-2021 re-opening plan would include: live synchronous learning in a block-schedule format, high quality instruction, re-engagement strategies, and the need for social and emotional supports. Parent concerns when returning to school include: class size and social distancing procedures, the importance of a vaccine, the increase in cleaning procedures, and increased hand washing and mask wearing at school. While some families would like 100% in class instruction, and others have chosen a 100% on-line option for the year, the majority of families chose a hybrid schedule when we returned to school in October 2020. The interaction between teachers and their students, as well as between classmates, were an important factor moving throughout the 2020-2021 the school year. As we started the 2020-2021 school year with distance learning, we quickly realized the importance returning students to in person instruction safely, while also building relationships between teachers and students as well as between peer groups.

Our foster youth, English learners and low-income students were considered first when we first returned to in-person learning. El Rancho offered a 4 day a week option for in person learning during the 2020-21 to those struggling academically and socially. This allowed for students with access to their teachers and support staff on a daily basis to support their learning. As we start the upcoming 2021-2022 school year, a double math class and an additional reading class will be provided to address unfinished learning. Before and after school programs as well as a twice a week tutorial will be implemented to support all students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Services will be increased or improved by offering the following for the 2021-2022 school year: Read 180 and a Reading block English class, additional classroom aide support throughout the day as well online support after the regular school day. In addition, an increase in the area of technology will be used to support student learning.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
