We are the NorthWest Gold Prospectors Association, a non-profit organization dedicated to promote the hobby of recreational gold prospecting and small scale mining.

Eagle City Park is available to us for our outings at no charge (unless you plan to camp overnight). The fee to camp overnight on outing weekends is \$20 per family for the whole weekend including Friday to setup.

The fee for non-outing days is \$20 per family per day, \$30 per family per weekend which includes Friday setup, \$100 per family per week and \$300 per family per month.

Unless otherwise noted, the NorthWest Gold Prospectors meet at 7:00PM on the second Thursday of each month at the **Hayden Eagles**, **#4080 located at 1520 W Wyoming Ave**, **Hayden**, **Idaho**. Refreshments are donated by the members and are served at the meetings. Exciting and informative programs are presented by members and guest speakers.

The members bring and donate items for our raffles. Items range from a can of beans to gold nuggets. Raffle tickets are \$1 each or 6 for \$5. We also have a 50/50 drawing each meeting and every person who signs in will be given a ticket for a door prize drawing.
