

ARTIST MANAGEMENT AGREEMENT

AGREEMENT

(Hereinafter referred to as "Manager").

WITNESSETH

NOW THEREFORE, in consideration of the mutual promises herein contained, it is agreed and understood as follows:

1. Manager agrees to collaborate with Artist to promote and build up community, those things include but are not limited to:
 - a) to represent Artist on video social media to promote Artist's works where possible.
 - b) Maintaining inventory of agreed works for sale.
 - c) Physical production of inventory where applicable.
2. Manager is not required to render exclusive services to Artist or to devote their entire time or the entire time of any of Manager's employees to Artist's affairs. Nothing herein shall be construed as limiting Manager's right to represent other people whose talents may be similar to Artist.
3. Artist shall be solely responsible for their own expenses and income.
4. Artist shall retain illustration scheduling priority, Manager shall retain right to seek other artist illustration to meet deadlines, after prior discussion and written acknowledgement from both parties.
5. Artist retains the right to work with or for any entity that may be similar to but not in direct competition to Manager.
6. The initial term of this Agreement shall be for a period of ONE (1) YEAR with a FOUR (4) YEAR annual irrevocable option from the date thereof to renew this Agreement by written notice e-mailed to Artist no less than SIXTY (60) days prior to the expiration of the initial term or option periods, as the case may be.
7. During the term of this Agreement, it is understood and agreed that there shall be no change or modification of this Agreement unless reduced to writing and signed by all parties (This can be in the form of a digital signature) hereto. No waiver or any breach of this Agreement shall be construed as a continuing waiver or consent to any subsequent breach hereof.

Terms and Conditions

8. Artist Pay

- a) Manager agrees to pay Artist FIFTY PERCENT (50%) of profit margin per eligible product sold.
 - i) Stickers (\$0.25USD)
 - ii) Books (\$12.50USD)
 - iii) Buttons (\$0.45USD)
 - i) To be eligible, product must contain element(s) of Artist's work, including but not limited to:
 - 1) Artwork.
 - 2) Proof of concepts (such as a sketch or other medium).
 - 3) Artist's designs that have been traced, reworked, and/or altered, used whole or in part.
 - ii) While payout agreement is being adhered to, Artist gives Manager permission and the right to use Artist's designs and artwork commercially and make alterations as desired.
 - iii) If Manager does not adhere to payout agreement and a verbal and written agreement cannot be reached, it will be considered an immediate breach of contract and **Dissolution** will immediately apply. In such an event, Artist may pursue legal means to recover payout amounts owed.
- b) Manager Agrees to pay Artist weekly accumulated payouts greater than or equal to \$10USD on Monday of each week.
 - i) If the accumulated amount is less than \$10USD, it is rolled forward into the next week, until an accumulated payout of greater than or equal to \$10USD is met, at which time Manager will provide total accumulated payout to Artist's Paypal.
 - ii) After full payout has been sent, payout shall reset to zero and begin accumulation cycle again.
 - c) Manager agrees to pay Artist on Monday of each week unless rescheduling is required or unavoidable, with written or verbal notification no later than the leading Friday.
 - d) Manager agrees to payouts less than \$10USD if fees are waived by the transfer service (Ex. PayPal fees waived)

9. Manager Pay

- a) Artist agrees to pay Manager FIFTY PERCENT (50%) per eligible product sold.
 - i) To be eligible, product must contain element(s) of Manager's work, including but not limited to:
 - 1) Artwork.
 - 2) Proof of concepts (Such as a sketch or other medium)
 - 3) Manager's designs that have been traced, reworked, and/or altered, used whole are in part.
 - ii) While payout agreement is being adhered to, Manager gives Artist permission and the right to use Manager's designs and artwork commercially and make alterations as desired.
 - iii) If Artist does not adhere to payout agreement and a verbal and written agreement cannot be reached, it will be considered an immediate breach of contract and **Dissolution** will immediately apply. In such an event, Manager may pursue legal means to recover payout amounts owed.
- b) Artist agrees to pay Manager weekly accumulated payouts greater than or equal to \$10USD on Monday of each week.
 - i) If the accumulated amount is less than \$10USD, it is rolled forward into the next week, until an accumulated payout of greater than or equal to \$10USD is met, at which time Artist will provide total accumulated payout to Manager's PayPal.
 - ii) After full payout has been sent, payout shall reset to zero and begin accumulation cycle again.
- c) Artist agrees to pay Manager on Monday of each week unless rescheduling is required or unavoidable, with written or verbal notification no later than the leading Friday.
- d) Artist agrees to payouts less than \$10USD if fees are waived by the transfer service (Ex. PayPal)

DISSOLUTION

10.

- a) Upon dissolution of contract, Manager will have up to 30 days to remove any designs or illustrations by Artist (Unless otherwise agreed upon prior to dissolution)
- b) Manager will have 30 days after dissolution to purchase commercial rights for any designs created by Artist that Manager would like to continue to use beyond contract agreement.
- c) Artist will have 30 days after dissolution to remove any design or illustrations by Manager (unless otherwise agreed upon prior to dissolution)
- d) Artist will have 30 days after dissolution to purchase commercial rights for any designs created by Manager that Artist would like to continue to use beyond the contract agreement.
