Training, assessing and quality assurance statement.

Global medical training has system in place to ensure quality assurance and due diligence. This document outlines the courses we offer and levels of qualification of our instructors delivering the courses.

- All our instructors hold as a minimum, a level 3 award in education and training (or equivalent) and some hold PCGEs.
- All our assessors hold a certificate in assessing vocational achievement (CAVA) or equivalent.
- All our instructors and assessors keep a continuing professional development log in relation to their teaching and assessing activities which is reviewed twice annually by an independent external quality assurer.
- All our Paramedics are registered with the Health & Care Professionals Council, as required by law.
- All our Nurses are registered with the Nursing and Midwifery Council, as required by law.
- All our registrants hold a minimum of a certificate in higher education (CertHe) in their professional area, with most holding bachelor's or master's degrees.
- All our registrants have a contract with an NHS organisation and regularly work on the NHS frontline. They are required to keep all their statutory and mandatory training up to date.
- Where an instructor is not a registrant, (e.g. an ambulance technician) they will hold a contract with an NHS organisation and will work regularly on the frontline.
- All our courses are ultimately overseen by a registered healthcare professional.
- Where we offer non-medical courses, our instructors are qualified to at least level 3 in the subjects, examples include:
 - Food Safety
 - Health & Safety
 - Fire Safety
 - Manual Handling
- Health & Safety and manual handling courses are run and overseen by a trainer qualified to at least IOSH or NEBOSH level.
- Any courses written by Global Medical Training Ltd. will always be written by a registered Healthcare Professional and peer reviewed by a team member of the same level.
- We will occasionally use subject matter experts to deliver bespoke training where required.
- Our courses and processes are internally and externally quality assured twice a year and a report obtained from an independent external quality assurer.
