NEW BUSINESS: As of July 1st, 2022, the state of Tennessee will no longer collect sales tax on the retail sales of coins, currency, and preciousmetals bullion. To date, this change in the law has not been reflected in information currently available on the Ebay or Amazon websites. The last pronouncement on the subject was Tenn. Dept. of Revenue Notice #20-15, which requires marketplace facilitators (like Ebay and Amazon) to collect sales tax on sales of tangible personal property based on the shipped to or delivered to address of the customer.

Jim Viken reported the financial results of the Gallatin Coin Show. The May 2022 coin show was the second best, in terms of net profit, since Jim Viken first took charge of our coin shows.... Dec. 2021 est. \$2,400; May 2022 est. \$2,000. The cumulative net profit for the last five coin shows was an estimated \$9,000.

Regarding our preparation for the upcoming Dec. 2022 coin show, Jim Viken reminded the members attending that he was no longer bourse

chairman and he called on members to start working on show committee tasks and arrangements for the Dec. 2022 show.

Next month's meeting falls on the July 4th holiday. Steven Meyer made a motion to skip next month's coin club meeting. It was seconded by Terry Hess. The motion passed with a majority vote.

A motion was made and seconded to vote upon whether the club should keep this checking account to hold NCC funds, or whether the account should be closed and the NCC funds transferred elsewhere so as not to be subject to bank account fees and restrictions. The result of the vote was 6-2 in favor of keeping the existing club account at Regions Bank.

Treasurer, Dave Osborn, stated his preference to reimburse all fees charged to the club account to date from his own funds since he did not obtain the approval of the club membership before establishing the bank account. A motion was made and seconded to vote upon whether to absolve the treasurer of responsibility for paying the fees incurred to date. The motion was passed without a negative vote.

The membership acknowledged that the BRNA Coin Show in Dalton, GA was coming up on Thurs. 8/4 through Sat. 8/6.
