There was a discussion about how to reach young coin collectors in the Nashville area. Boy Scouts and Girl Scouts can earn merit badges relating to coin collecting. Flyers can be posted on high school and elementary school bulletin boards. Also, kids pass through the Nashville and Lebanon flea markets and dealers in attendance could have flyers available.

NEW BUSINESS: Upcoming coin shows include the BRNA Annual Convention in Dalton, GA (8/24 - 8/26/18) and the West Tennessee Collectors' Club Annual Coin Show in Jackson, TN (9/8 - 9/9/18).
