

DEC 2023 - GALLATIN COIN SHOW REPORT

- 547 door prize tickets were issued to attendees during the show (306 on Friday & 241 on Saturday) .
- The numbers for 13 hourly door prize tickets were announced during the show (7 on Friday & 6 on Saturday). 2 of the hourly door prizes were claimed on Friday and 1 was claimed on Saturday.
- 2,143 postcards mailed; ____ were returned by attendees at the registration table. The grand prize (an American Silver Eagle) was awarded to an attendee from Springfield, TN.
- 271 registration table giveaway coin envelopes were distributed to attendees during the show.

- For the upcoming May 2024 show, we have already collected \$3,610.00 in table rentals from 22 dealers.
- I received a suggestion that we provide a trash receptacle for each dealer on the floor of the show.
- I received a complaint from a dealer regarding the positioning of dealer tables on the floor. He suggested that we organize the tables into four islands instead of long rows so a dealer doesn't have to walk as far to find another dealer on the floor. This would result in the loss of approximately four - 8 ft. tables. We could make up the shortfall by charging say half-price for all corner tables.

- I received a suggestion that we provide a plastic grocery bag rather than a tall kitchen bag to each dealer who sets up at the Dec 2024 show. The tall kitchen bags are proving too large and cumbersome to use.
- I received a complaint from a dealer about changing the closing time for the show from 6:00PM on Friday to 5:00PM. This dealer claimed that he lost over \$2,000 of business with a client because of the closing time change. I explained to the dealer that the closing time change was ordered by the Ass't Director, Administration of the Civic Center, Robby Riley, in order to insure that the building was completely vacated by 6:00pm, and I had no choice but to comply with his request.
- Mr. Riley also told me that, for subsequent shows, the 8 ft. table presently located in front of the "Office Area" had to be removed. Furthermore, the seven 8 ft. tables on the back row of the gymnasium in front of the stage had to be moved toward the exit door so that an access door to the concession stand would not be blocked. If moving the tables resulted in the storage room near the exit door being blocked, then we will have to remove one of the 8 ft. tables from the back row.
