The cost of the spay or neuter is covered by the adoption fee provided if: (1) The animal is taken to one of the Veterinary Clinics authorized by Safe Harbor and, (2) *the adopter presents the Veterinary Clinic with the adoption Certificate they received at the time of the adoption.* (3) *pets unaltered will be repossessed* **UNALTERED PETS MUST BE FIXED ON TIME CATS 4LBS OR 4 MONTHS DOGS 6 MONTHS**

If in the event you find your living situation has changed and you are no longer able to care for your adopted pet, you MUST RETURN your pet to the sanctuary.(please call ahead) You must notify us if ANYONE other than YOU will have ownership of the Animal. We must approve the new owner BEFORE said Animal is given to that person.
