

The following Terms of Use are entered into by and between you and China Golden Bridge Group Limited (“Golden Bridge Art” or “we” or “us” or “our” or other similar pronouns) and, together with any documents incorporated herein by reference, govern your access to and use of Golden Bridge Art’s website at [www.goldenbridge-art.com](http://www.goldenbridge-art.com) and/or Golden Bridge Art’s applications for mobile and tablet devices (collectively, the “Electronic Platforms”).

We may change these Terms of Use from time to time, at any time without notice to you, by posting such changes on Golden Bridge Art’s Websites. By accessing the Electronic Platforms, you are agreeing to these terms.

1. Materials on the Electronic Platforms
