PUBLIC SERVICE ANNOUNCEMENT REQUIREMENTS

WPVI-TV

- 1. Spot must be sponsored by and benefit a non-profit organization with 501(C) 3 status. The announcement should promote <u>specific</u> activities, events, or programs of the organization.
- 2. We have a general policy of not running spots for educational institutions for the purpose of student recruitment. Also, we tend to reject spots which are in any way related to commercial organizations or lobby for a controversial point of view.
- 3. Message should be of <u>broad</u> interest because we're a regional mass medium.
- 4. Spots are aired at our discretion throughout the broadcast day. However, we try to place the spot in time periods which appropriately match the audience that the spot seeks to reach.
- 5. Length of PSA's -- 10, 15, 20, 30, or 60 seconds.
- 6. Spots should be submitted on one-inch, reel-to-reel videotape or broadcast beta. We also accept written copy for "Community Connection" PSAs.
- 7. Spots should be submitted at least three (3) weeks in advance of beginning airdate. It's helpful to indicate a start date and a cut-off date for each spot.
