- Basketballs will be provided for warm-ups
- **NSPL Rules** will govern play with slight modifications
 - Warm up: 4 minutes
 - <u>Clock:</u> Two 18-minute halves with running clock. The clock will stop for all timeouts and for dead balls in last 2 minutes of each half. If a team is leading by 15 points or more the clock will not stop (except for timeouts)
 - <u>Timeouts</u>: 3 Full timeouts and 2 thirty-second timeouts per game (1 timeout only for each overtime period)

 - Press: Press is allowed for all grades at any time, except when the lead is 15 points or more.
