A fter not getting any selections on last year's All Area team, the Bulldogs made up for it this season as they placed more players on the team than any other school.


Senior Ta'Nyah Smith made the first team, as she should have been last year, along with freshman Zeri Tyler. Trenity Morales was honored with a second team selection.

- 1 3/4 cups reduced-fat creamy peanut butter, divided
- 1/3 cup butter, softened
- 1 cup packed brown sugar
- 3/4 cup sugar
- 2 eggs
- 1/2 cup unsweetened applesauce
- 1 teaspoon vanilla extract
- 2 cups all-purpose flour
- 2 cups quick-cooking oats

teaspoon baking soda

- 4 1/2 cups confectioners sugar
- 1/3 cup fat-free milk
- 1/4 cup baking cocoa
- 1/4 cup butter, softened
- 1 teaspoon vanilla extract
- 1/2 teaspoon salt
- 1. In a large bowl, cream 1 cup peanut butter, butter, brown sugar, and sugar until light and fluffy. Add eggs, one at a time, beating well after each addition. Beat in the applesauce and vanilla. Combine the flour, oats and baking soda; gradually add to the creamed mixture and mix well (batter will be thick.)
- 2. Spread into a 15 x 10 x1-inch baking pan coated with cooking spray. Bake at 350 for 18 to 22 minutes, or until lightly browned. Cool on a wire rack for 10 minutes; spread with the remaining peanut butter. Cool to room temperature, then refrigerate for 30 minutes.
- 3. In a large bowl, beat frosting ingredients until light and fluffy. Spread over the peanut butter layer. Cut into bars.






# DeSoto Secondary School Chromebook Distribution
