DESOTO COUNTY REMEMBERED 9/11



The sun highlighted the oversized U.S. flag displayed on a ladder truck at 8:45 a.m., the time that American Airlines Flight 11 crashed into the North Tower of the World Trade Center complex in New York City on Sept. 11, 2002.

Firefighters, paramedics, and law enforcement officers-plus their families, friends, and others in the community-gathered in the shade on the east lawn of the courthouse to remember Sept. 11, 2001-called by some "the deadliest terrorist act in human history." The tragedy was certainly the deadliest incident in U.S. history for firefighters and law enforcement personnel-340 and 72 killed, respectively.

Ron Jones, Sr., commander of American Legion K-Post 11, posted the U.S. flag, and City Administrator Terry Stewart sang the National Anthem. The Rev.

Lonnie Walker, pastor of the Nocatee Church of God, led the recitation of the Pledge of Allegiance and said

After calling for Sheriff Jim Potter and Marshal Quinn Jones to stand beside him, Public Safety Director Chad Jorgensen said, "We live in troubled times, so it's even more important to remind ourselves of what happened 22 years ago." He chronicled how at 8:45 a.m., American Airlines (AA) Flight 11 crashed into the North Tower of the World Trade Center complex and at 9:03, AA Flight 175 slammed the South Tower. Firefighters worked to extinguish the blazes, and some who had worked in the North Tower before it fell, then worked in the South Tower knowing that it would probably go down as well.

After AA Flight 77 hit the Pentagon at 9:37 a.m., causing a partial collapse of the structure, Jorgensen recalled his thought: "Something extraordinary is happening." At 10:03, passengers on United Airlines Flight 93 who had heard of the other attacks, forced the pilots to crash the plane into a pasture. Jorgensen said, "They were true heroes in my opinion." In all, 2,977 people died in the attacks.

Battalion Chief Tim Allen read the "Firefighter's Prayer," written by Alvin William "Smokey" Linn (1924-2004) after not being able to rescue some children from a burning apartment building.

A recording of the song "Where Were You When The World Stopped Turning" by Alan Jackson was played, and then Lt. Chase Redman tolled the bells-a tradition since the midnineteenth century-when a firefighter dies. He played five strikes in a series of four on the bell mounted on the bumper of the ladder truck displaying the huge U.S. flag. Then a recording of a piper performing "Amazing Grace" was played.

K-Post 11 Honor Guard: Ray Dennison, David Fonger, Bob Grinis, and Commander Ron Jones gave a gun salute followed by Arthur Southwell playing "Taps."

Rev. Walker said the closing prayer after reminding us that firefighters and law enforcement officers "take care of us and protect us." He suggested that as we thank those who serve in the U.S. Armed Forces, so, too we should thank those who serve DeSoto County and each one of us.

BROWN, KEITH LEAD BULLDOGS TO 28-12 WIN

Kemarion Brown gained nearly 100 yards rushing in the first half and scored both touchdowns for the middle school Bulldogs. Andre Keith owned the second half with a pair of touchdowns to provide all the scoring DeSoto would need to run through Hardee 28-12 in their opening game of the season.

The Wildcats needed just 5 plays to take a 6-0 lead on the opening drive of 65 yards. DeSoto answered as Brown ripped off runs of 32, 8 and 10 yards in an 8 play drive to tie the game. A two point conversion gave the Bulldogs the lead that they never lost.


The Wildcats faced a 4th and 7 when the Bulldog defense stood tall and sacked the guarterback to give DeSoto the ball. Keith ripped off a 20 yard run to the Hardee 45. Brown went the next 22 yards. Kolten Bullards took the pigskin the next 22 yards to the Wildcat 1 where Brown punched it in giving the Bulldogs a 14-6 lead.

Bullards' carry looked as if he had crossed the pylon in bounds but he was ruled out on the one. Hardee responded with a 59 yard touchdown with 1:42 left in the half. The two point conversion failed. DeSoto moved the ball to the Hardee 34, but a dropped pass and costly penalty on a run to the Wildcats' 8 yard ended the half with DeSoto on top 14-12.

Keith scored on a 25 yard run with 5:17 remaining in the third quarter. A two point pass to Bullards, who was all alone in the end zone, gave the Bulldogs a ten point lead 22-12. Brown set up the final touchdown with a 27 yard carry which put him well over 100 yards for the game. Keith went the final 7 yards with 1:42 left in the game for the final score. It was the same time that the Wildcats had scored at the end of the

For the second time in three weeks, the DeSoto County Athlete of the Week award goes to members of the middle school sports program. Also for the second week in a row it is a shared honor by two football players.

Andre Keith scored two second half touchdowns and ran in a two point conversion along with passing for a two point conversion in the 28-12 win over Hardee. It was the first win over Hardee in over ten years at the middle school level.

Head coach Matt McCray said, "Andre joined our team this year as an eighth grader. He has emerged as our starting quarterback as a first year player. Andre has become a natural leader of our team."

Brown picked up 50 yards rushing on three carries in the first Bulldog drive to put DeSoto ahead. He had another big run of 22 yards in the second drive and had another big gain of 27 yards later in the game as he crossed the century mark in rushing. He scored both first half touchdowns to give the Bulldogs a 14-12 lead at halftime.

McCray had this to say about Brown. "Kemarion started at fullback and carried a heavy load to pick up the win over the Wildcats. He led our backs in yardage and with two touchdowns."

DeSoto football coach Jeff Lee said they had a couple of very good practices during the week and the results showed on the field. The Bulldogs lost to George Jenkins 46-7 but they did make progress in the rebuilding of the team.

They had a 41 yard, 7 play drive to start the game highlighted by Braden Moran's quarterback keeper on the first play for 17 yards. The drive ended on a failed fourth down attempt at the Eagles 30 yard line.

The Bulldogs' second drive went 48 yards to total 89 yards in the first guarter alone compared to the 103 they got in the entire game the week before at Mariner.

When the Eagles took a 6-0 lead, the Bulldogs didn't roll over and quit. They answered with their first touchdown of the season ending a 9 quarter drought. Hunter Zirkle skirted the left side for 33 yards to give the Bulldogs their first lead of the season 7-6. That lead lasted 55 seconds as the Eagles came right back to score to take a 12-7 lead.

A turnover filled second quarter put the game out of reach as the Eagles took a 32-7 lead into the locker room. DeSoto failed to recover an onside kick and coughed up the ball on a fumble and two picks to aid the Eagles.

The Bulldogs recovered an Eagle fumble when the receiver made a catch and Rylan Unruh laid the lumber to him causing a fumble that Hayden Ames came up with. It wasn't enough as DeSoto fumbled it right back.

George Jenkins scored once in

both the third and fourth quarter to account for the 46-7 final. Moran had an interception in the third quarter to halt an Eagles drive at the Bulldogs' 14.

DeSoto played a much cleaner game with just 3 penalties in the game and all came in the second half. The Eagles had 7 in the first half and nothing in the second half. There was a 7 man referee crew working the game which was unusual.

Lee told the team in the locker room, "We took some steps in the right direction and played hard. There were some good things out there and we will see on the film how those turnovers came back to bite us in the butt."

The Bulldogs have a bye tomorrow night.



"FEMALE FOCUS" HONOR FLIGHT INCLUDES COLLINS

Since Naomi Copeland became president of Southwest Florida Honor Flight (SFHF) 18 months ago, her passion has been to have an all-women Honor Flight. The upcoming flight on October 10 has a "female focus" because it will transport more women veterans than ever before-around 40including Council Member and Veteran Amber Collins.

Born in West Virginia, Collins moved-at age four-with her family to Charlotte County, Florida. After graduating from high school, she joined the U.S. Army and served in the 82nd Airborne Division. Now a registered nurse (RN) and resident of Arcadia since 2018, she was elected to the City Council last year.

Copeland said, "We want to recognize women veterans because sometimes we fall a little short in honoring them. I admire the women who served and want to say 'thank you'."

She, Treasurer Hank Carter, and Medical Director Alex Davenport were in Arcadia on Sept. 5 to accept from Mayor Bob Heine, Jr., a proclamation about SFHF, a not-for-profit 501(c) (3) organization dedicated to safely transporting veterans to Washington, D.C., "to be honored at their memorials and receive the welcome home they deserve."

Priority is always given to World War II and Korean War veterans as well as any veteran with a terminal illness. A mother of two U.S. Navy servicemen, Copeland said, "It's super important to honor the women and men who have served in our armed forces."

SFHF serves the counties of Charlotte, Desoto, Hardee, Hendry, Highlands, Sarasota, and surrounding areas. About 49,000 veterans live in those six counties. Since 2007, SFHF has transported about 2100 veterans who were flown to D.C. to visit the World War II Memorial, Korean War Veterans Memorial, Lincoln Memorial, Vietnam Veterans Memorial Wall, Military Women's Memorial, and Arlington National Cemetery where they witnessed the changing of the guard at the Tomb of the Unknown Soldier. Besides transportation and meals, the veterans also enjoyed surprises throughout the day-plus a huge "welcome home" when the aircraft landed at the Punta Gorda Airport. The one-day trip is free for all veterans.

As Medical Director, Davenport ensures the health and safety of all those on the trip. He noted that veterans from World War II and the Korean War are becoming scarce, so he explained that SFHF will also take the burial flags of those veterans who have not participated in an Honor Flight and

photograph them at their memorials.

In the John Morgan Ingraham House Museum, the DeSoto County Historical Society displays the burial flag of Eugene "Gene" Melton (1922-1943), brother of Howard Melton, local historian and published author. A U.S. Marine training to be a gunner on a bomber, Gene was killed when his aircraft crashed in the Mohave Desert. His flag will be transported to the World War II Memorial on Oct. 10.

Many non-combat, female, and Desert Storm veterans feel that "the older guys should go first," Carter said. However, he encourages those who say that "to prioritize themselves. . . .we do not want to have them wait." Veterans interested in the trip should complete the application form at www. SWFLHonorFlight.org or print, fill out, and mail it, or call 941-268-3925 and ask for Hank. DeSoto County's Veterans Service Officer Steve Rickard, U.S. Army Retired, also has copies of the application available from 10:00 a.m. to 2:00 p.m., Mon. through Fri. in the DeSoto County Administration Building,

201 E. Oak St., Suite 202. Davenport said that the organization welcomes donations and volunteers. The SFHF Website has a secure portal where people may donate. A donation of any size-even \$1.00-is welcomed. Donations can also be set up to be recurring. For example, one person donates \$12.00 every month.

Copeland also said that the first corporate sponsor has donated \$3,000.00 to SFHF. She welcomes donations from businesses, individuals, plus legacy bequests and corporate sponsorships. In addition, the SFHF holds fundraisers, such as the upcoming golf tournament on Sat., Oct. 28, at Riverwood Golf Club in Port Charlotte. The deadline for sponsorships is Sept. 15, and more details are available online at swflhonorflight.org.

SFHF meets on the fourth Wed. of every month at the Punta Gorda Fire Station, 1410 Tamiami Trail, and volunteers are welcome to attend.

COUNCIL ADOPTS TENTATIVE MILLAGE RATE AND BUDGET

At a public hearing at 5:01 p.m. on Sept. 5, the Council passed two resolutions concerning fiscal year 2023-2024: 2023-08 adopting the tentative millage rate of 7.9000 and 2023-09 adopting the tentative city budget of \$49,328,550.00. Council Member Mike Hall opposed the latter. The final public hearing for the millage rate and budget will be at 5:01 p.m. on Sept. 19.

The Council passed Ordinance 1098, on second reading, amending the Police Officers' and Firefighters' Retirement System Sections: 2-184 Finances and Fund Management, 2-187 Pre-Retirement Death, 2-196 Minimum Distribution of Benefits, 2-206 Military Service Prior to Employment, 2-207 Prior Police Service, and 2-211 Supplemental Benefit Component for Special Benefits.

On first reading, the Council approved Ordinances 1099 and 1100, amending the Future Land Use Map and Official Zoning Map, respectively, to allow a strip of property east of 12th St. to be rezoned from Public Buildings and Grounds / B-2 Central Business to R-1B Single Family Residential. This change will allow properties to the east of the parcel to have a driveway access to 12th Street.

THE COUNCIL ADOPTED TWO **RESOLUTIONS:**

2023-7 extending the Code **Enforcement Lien Waiver/Amnesty** Program for an additional six months from Sept. 1 to Feb. 29, 2024: "The Program may likely also

- stimulate the sale of abandoned properties that might otherwise be unmarketable as a result of being encumbered by code lien(s) which have accrued to an amount that exceeds the market value of the property; and
- 2023-12 extending the State **Revolving Fund Loan Agreement** DW140131 with principal forgiveness from Aug. 15, 2023, to May 15, 2024, so that construction may be completed by March 11, 2024, with the date of the first loan payment to be Nov. 15, 2024 instead of Feb. 15, 2024.

EXPENSES

As required by ordinance, both Marshal Quinn Jones and City Administrator Terry Stewart asked for the same 10% increase to their salaries as was approved for all city employees. Jones noted that in Nov., he will have worked in the police dept. for 23 years. Stewart based his request on his 4.4 out of 5 performance evaluation and that he had not accepted a raise since 2021. Collins and Hall were opposed.

The Council concurred with the emergency work completed by Andrew Sitework in the amount of \$69,418.00 for the cleanup and rehab of the Bridle Path/Cemetery ditch. The swales were repaired; trees and other vegetative debris removed from the ditches; and sod added as needed.

City staff presented the American Rescue Plan Act (ARPA) list for spending the nearly \$4.2 million received in 2022. Of the ARPA Priority List approved in Feb. 2022, close to \$1 million was spent. Projects now include the following by department:

Airport: construction of three shade hangars for \$150,000.00;

- Golf Course: remove existing and install new irrigation system for \$400,000.00;
- Parks: build the pavilion at the park on Martin Luther King St. for \$180,000.00;
- Public Works: rebuild the infrastructure and road on Volusia Ave. for \$898,000.00; other road paving/milling projects for \$700,000.00 as well as storm water improvements (ditch clean out) for \$375,000.00;
- Utilities: rebuilding the East clarifier for \$150,000.00; connecting the golf course ponds for \$50,000.00; building a lift station for 12th Ave. for \$200,000.00; and Smart Manhole Covers for \$50,000.00.

Police Capt. Kevin Joens requested additional funds added to the \$20,000.00 on the list to construct a metal training building at the gun range. The 40' x 60' cement slab is in place, but no contractor will assemble the metal building that was donated.

The Council voted to add \$80,000.00 to the project: they moved the \$50,000 slated to connect the golf course ponds to the training building and added \$15,000.00 each from the road paving/milling and the storm water improvement projects, for a total of \$100,000.00 to construct the training building. Collins voted against the change.

Dear DeSoto County, In the third week of September, DeSoto County Sheriff's Office is proud to address an annual recognition week that serves as a crucial reminder of the importance of safeguarding our most precious cargo when on the roadways - our

children. As your Sheriff, I am committed to the safety and well-being of our community, especially our youngest members. From September 17 -September 23, 2023, we will come together to raise awareness about the vital steps we can take to ensure our children are protected when traveling in vehicles.

The Importance of Child Passenger Safety

Car crashes are a leading cause of death for children, as 710 children under 13 were killed in passenger

vehicles in 2021, and more than 100,000 were injured. In 2021, more than 36% of children under 13 who died while riding in passenger vehicles were unrestrained. It is our collective responsibility to reduce these statistics and ensure every child in our community is safe when they are inside a vehicle.

Choosing the Right Child Safety Seat

Selecting the appropriate child safety seat is the first step toward ensuring a safe ride for your child. Factors such as age, weight and height should all be considered when choosing the right seat. Infant seats, convertible seats and booster seats are designed to provide the necessary protection for children of varying ages and sizes. I advise you to always follow the manufacturer's guidelines and ensure a snug and secure fit for your child.

Proper Installation is Key

Even the most advanced safety seat will only be effective if it is

installed correctly. This is where many caregivers inadvertently put their children at risk. I urge each of you to take the time to read your vehicle and child safety seat manuals carefully. If you have any doubts about installation, consider seeking assistance from a certified Child Passenger Safety Technician, or visit the DeSoto County Sheriff's Office.

Seat Belt Safety for Older Children

As our children grow, it is essential to transition them to the appropriate type of restraint system. Seat belts play a critical role in protecting older children and adults. Ensure that your child is tall enough to fit comfortably without a booster seat and understands the importance of always wearing a seat belt.




