20TH ANNIVERSARY OF

HURRICANE CHARLEY

The DeSoto County Historical Society presents a 20th Anniversary Exhibit of Hurricane Charley at the DeSoto County Library, 125 N. Hillsborough Ave., from Aug. 10 through 31. It is free and open to the public during regular library hours.

The Society began gathering photographs, newspaper articles, and artifacts for the exhibit last Sat., Aug. 3, and the public was invited to share their materials. At the same time, Tropical Storm Debby approached the State. It sloshed through southwest Florida, dumping rain, and became Hurricane Debby on Aug. 4. It made landfall at 7:00 a.m., Aug. 5, near Steinhatchee, Florida, as a Category 1 hurricane with sustained winds of 80 mph. It continues to ransack the southeast coast of the U.S. with torrential rains and catastrophic flooding.

A Category 4 storm, Hurricane Charley was a very different event although it churned north along the the west coast of Florida as did Debby. However, Charley made the infamous right-turn up the Peace

River Valley. Not only did it have 150 mph sustained winds when it made landfall at 3:45 p.m. on Friday, Aug. 13, 2004, but it also had a forward speed of 21 mph or more. It followed on the heels of Tropical Storm Bonnie, the first time that two tropic disturbances hit one state within a single day.

Several Society members said that they didn't care to remember Hurricane Charley because of its devastation and their personal losses. However, the Board of Directors voted to hold the exhibit as part of the Society's mission to promote and preserve the history of DeSoto County for future generations.

MAASSEN OIL COMPANY: GOING, GOING...

At their new office location, 119 S. DeSoto Ave., the Maassen Oil Company, Inc., sign will soon be replaced by one for Palmdale Oil Company, "Florida's largest bulk fuel and oil supplier" (palmdaleoil.com). As Maassen was liquidating some of their assets, Palmdale purchased the bulk oil tanks and then the Maassen company itself.

"This opportunity will allow me to retire," Edward Maassen said, although not for a while as he has two companies to close out. "You do something your whole life," he said, "and it becomes second nature."

His son, Tyler Maassen, will continue as general manager of the Arcadia location and supervise the same employees and route drivers. "Customers probably won't notice anything different except the name change," Edward said. They will soon receive a letter notifying them of the transition.

He and his brothers-David and Johnny-are the grandsons of John Samuel Maassen (1893-1942) and Edna Norene Murray Maassen (1896-1977). They founded the company in 1931 as a small service station, Standard Livery and Garage, in Arcadia.

In 1940, Maassen purchased the Shell Oil distributorship for Charlotte, DeSoto, Glades, Hardee, and Highlands counties. As he had been doing the distribution, he told his clients that there would be "no change in the service."

The family later built Shell service stations on the city's major north-south route-U.S. Highway 17- (612 N. and 303 S. Brevard Ave.) and east-west highway-State Road 70-(1001 E. and 1072 W. Oak St.).

The Maassen family leased the Shell service station at 612 N. Brevard Ave. to Louis Stewart (1920-2002) for 43 years starting when he returned from serving in the U.S. Army's 6th Armored Division during World War II. Even after he retired, he continued to help out at the business and always enjoyed talking with customers.

In an interview with Patti Magee on the occasion of his retirement, he described the shop he once operated in the station. Stocked with "bread, milk, soft drinks, crackers, and canned goods," it was "sort of the precursor to the 7-11's" ("DeSoto County Times," Sept. 6, 1989).

The Maassen family built a new service station in 1972, and that structure will soon be demolished in preparation for the construction of a 7-Eleven convenience store. Established in 1927 in Texas, 7-Eleven was the first convenience store to sell gas, fresh coffee in to-go cups, and offer a selfserve soda fountain that included the Slurpee starting in 1965 (corp.7-eleven. com).


Some people may remember Jed's, the convenience store at the West Side

Shell, 1072 W. Oak St. Although Jed is usually a shortened form of the name Jedidiah, the brothers chose it because it was spelled with the first letter of each of their names: Johnny, Edward, and David. Edward said, "The face on the sign is a family caricature."

After his grandfather died, Edward said that his grandmother "kept the business going" because his dad, J.S. Maassen, Jr. (1918-2006), DeSoto High School Class of 1935, was serving in the U.S. Navy. After World War II, he returned to Arcadia and ran the firm. His sons-David, Edward, and Johnnyeventually took over the company.

He and his brothers united "against our common enemy-Dad," Edward said. "We've worked together our whole lives,

and we've never had any problems. All of our business decisions have been made by the three of us."

contact after so many conditioning drills.




"I'm hoping to start at least at one

NEW COACH, NEW SEASON BEGINS NEXT WEEK

Danielle Taylor knows she has some big shoes to fill in her first season as the head coach of the DeSoto Bulldogs volleyball team. Her predecessor and former coach Dave Bremer stepped down after 3 decades as the face of DeSoto volleyball. Bremer has earned respect and admiration form all over Florida from his coaching opponents. This hasn't escaped Taylor as she held her first session of tryouts for the upcoming season.

"I'm a little nervous about that. I've got all the excitement and feelings that comes with the position. Coach Bremer has called me daily to offer encouragement. He has reminded me about certain things and I've told him I've done this and that and he says it sounds like you have everything under control. He said 'you've got this'. That feels good to get that encouragement from him."

Coming into the season she has lost 4 players due to graduation. Samantha Hershberger, Raegan Hancock, Chloe Pomerleau and Hannah Jones were all big contributors to the team last season. She knows that it will be hard to replace experience, but she has a couple of incoming freshmen that she coached at the middle school and has high hopes for them.

"We also have Natalie (Lafond) coming back who will play in the front row and senior Emery Skinner is back and will fill in the back row so we should be all right when the season starts."

A huge addition will be the return of Yahri Tyler. The All Area player as a freshman sat out the entire season last year with a knee injury and rehabilitation. "Yahri has been cleared by the doctor and has been in summer conditioning with us and is ready to play," said Tyler.

Tyler said, "my knee feels good and I'm wearing the brace just for preventative measures. I feel good and no pressure on me to come back and be as strong as I was 2 years ago. I'm just glad to be back and playing."

Joining Taylor on the staff will be Brooke Zolkos as the varsity assistant coach. Long time volunteer coach Jarrett Zolkos will return in the same position. Heading the JV team will be two very experienced coaches and former players with Lucretia Gilmore as the head coach and Kristie Joens as the assistant. Both have sons from the baseball team that graduated last June and are eagerly excited about getting back into coaching.

The season begins next Tuesday with a pair of preseason games at Riverdale. They begin their regular season on the 20th as they travel to Charlotte and then host Port Charlotte two night later.

Taylor's final thoughts about the upcoming season? "I just want to make coach Bremer proud."

BIBLICAL PERSPECTIVES

"I. I am he who blots out your transgressions for my own sake, and I will not remember your sins" (Isaiah 43:25).

Recently I came to the crushing reality that I had forgotten something. I wanted to do some planning for our upcoming sermon series and knew that if I worked at the office during the week there would be a myriad of distractions that would intrude. So, the wife and I went to Orlando. I can work undistracted, and she can play at the resort.

Well, we got to the resort, and when we were finished unpacking I realized that my backpack with computer, books, and Bible was still at the house. Many would call this a "senior" moment, and I suppose I fit the bill. But it was gutwrenching to then have to deal with the consequences of my forgetfulness.

The next morning, I rose early and left for home. I retrieved my backpack along with some incidentals that were also forgotten, though not nearly so monumental, and headed back.

That allowed me considerable time to chew on forgetfulness, and it left me praising God that he, too, is forgetful. Now, my forgetfulness is due to my finitude, and the progressive loss of brain cells that comes with aging.

The striking thing about God is that he purposes to forget. And even in this we can marvel at the greatness of our God. Most of us have been exhorted a few times to "forgive and forget." Sounds easy, but the reality is something far different. It is truly

difficult for us to forget, and maybe equally hard to forgive.

The other thing about God's forgetting is that it is rooted in remembering. When the last plague was to pass through Egypt, the Israelites painted their doorposts with the blood of a sacrificed lamb. When death came for the firstborn in Egypt, the blood was a reminder that atonement had been made, and death would Passover those houses.

But all of the sacrifices in the Old Testament were pointing to when God himself would blot out our transgressions. And he would do it for his own sake, desiring to ransom a people for himself. "But when the fulness of time had come, God sent forth his Son, born of woman, born under the law, to redeem those who were under the law, so that we might receive adoption as sons" (Gal. 4:4).

And all of this got me singing.

For nothing good have I Whereby Thy grace to claim; I'll wash my garments white In the blood of Calv'ry's Lamb.





WARNING! DANGER APPROACHING! **GOLF COURSE LIGHTNING DETECTION SYSTEM**

At the center of the Arcadia Municipal Golf Course is Hole #4 and a lightning detection system manufactured by Perry Weather, Inc., in Dallas, Texas. "It detects all lightning strikes within your area down to 100 meters of accuracy, using the National Lightning Detection Network, the same system used by the U.S. government and military" (perryweather.com).

More than 1,000 organizations-

including cities, golf clubs, industrial firms, and schools-rely on Perry Weather for public safety. The company has sent more than 50 million alerts to their customers for conditions ranging from heat stress to lightning.

When lightning strikes within a pre-determined area (0-10, 10-20, and 20-30 miles), strobe lights flash and sirens sound, plus broadcasts announce the disruptive weather, so that those on the course may seek shelter. In addition, golfers may download the application for alerts on their cell phones by using the QR codes posted through the pro shop.

In addition, the solar-powered

system provides low and high temperatures as well as forecasts that help with planning events, such as golf camps, clinics, and tournaments.


