

**PARENTAL CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

My minor child, \_\_\_\_\_, ("the Minor") has been accepted as a tutee/mentee in the Task Force Mentor Foundation assistance program (hereinafter "Program"). It is coordinated by Task Force Mentor Foundation (hereinafter "TF Mentor") The Minor has my consent to attend virtual sessions through Zoom. I understand the nature and requirements of the Program. With that understanding, it is my judgment that the Minor is qualified and able to participate in the Program. I acknowledge that the Minor's participation in the Program is voluntary.

Due to the age of the Minor, TF Mentor requires that this Agreement be executed by me in consideration of the Minor's being permitted to enroll in the Program. I agree to and acknowledge the following:

1. (1) I am the Minor's parent or legal guardian.
2. (2) I agree that the Minor will abide by all of rules and regulations and, if found in violation, may be removed from the Program either temporarily or permanently. I understand that TF Mentor may withdraw the Minor's participation if these programs are disrupted or altered in any way by the Minor's behavior. I further agree that as a parent or guardian of the Minor, I take full responsibility for the behavior and conduct of the Minor and any consequences resulting from his or her actions.
3. (3) I agree that the Minor may be photographed, audio or videotaped by TF Mentor. I agree that photographic image(s) and information that correspond with the photographic image(s) may be disseminated for any public usage by TF Mentor.
4. (4) As parent of the Minor, I understand that there are safety risks associated with the Minor's participation in programs and activities designed. I acknowledge and agree that I have had the opportunity to ask questions of TF Mentor officials concerning these matters, and all questions have been answered to our satisfaction.
5. (5) On behalf of ourselves, our heirs, executors, and administrators, I waive and release forever any and all rights for claims and damages I may have against TF Mentor (both individually and jointly), their trustees, officers, employees, and agents in any manner due to any personal injury or property loss sustained as the result of the Minor's participation in the Program. I hereby indemnify and hold harmless from and against any and all claims, demands, judgments, losses and expenses, including, but not limited to, attorneys' fees for personal injury or death to the Minor or damage to the Minor's property during the Program period arising out of or resulting from the negligent or wrongful acts or omissions of TF Mentor, and their employees, volunteers, and agents with the exception of gross or willful misconduct.
6. (6) I agree that should there be disagreements or problems with the implementation of this agreement, the laws of the United States will govern any resolution. I further agree that should litigation or grievances result, the forum for any lawsuit, hearing or adjudication shall be in Delaware.
7. (7) As parent of the Minor, we agree that I will promptly communicate any problems or issues associated with the Minor's participation in the Program with TF Mentor officials. I further agree that I will promptly report and disclose to TF Mentor officials all pertinent information concerning the Minor's ability to participate successfully in the Program.
8. (8) **Zoom Usage** Parent/guardian acknowledges that TF Mentor Volunteers use Zoom for all remote tutoring sessions and consultations. Parent/guardian affirms they have read Zoom's Children's Educational Privacy statement (<https://explore.zoom.us/en/schools-privacy-statement/>) and consents to the educational data collection when their child(ren) uses Zoom for remote sessions.
