

**CHANGES THIS SEASON:** Due to the number of 2nd trailer spots requested and not always used, ALL 2nd trailers that do not fit within your assigned parking spot will now be located on the west side hill in designated trailer overflow parking.

**ALL CHSRA D3 members and parents are responsible for following all parking rules REMINDERS, RULES, and REGULATIONS.**

1) **PARKING/HORSE STALL FORM:** ALL members needing parking and/or horse stall(s) must complete a new form for each rodeo season. Please submit **ONLY ONE (1)** parking/horse stall form **per** family. You will receive an email once the form is submitted, **SAVE THIS EMAIL** to edit your form/request later. To receive assigned parking/horse stall(s), requests must be received **prior to close of entries for your first rodeo.** Assigned parking and stalls will only be reserved/held for contestants who get entries submitted on time.

2) **PARKING RESERVATIONS:** Parking can only be reserved for campers, LQs, RVs, and trailers. All extra vehicles can park in the spectator parking area designated on the parking map. **PLEASE NOTE:** All rigs must stay within your assigned parking area, including any opened doors, slide outs, pop outs, vehicles, etc. **Please keep ALL vehicles out of the roadway/FIRE LANE and STAY WITHIN THE LINES.** Visitors must park in spectator parking if they cannot fit with the lines.

3) **RENTAL DROP-OFFS:** All rental drop-offs (camper, RV or trailer of any type) shall be dropped off the Friday before the rodeo and picked up Sunday or Monday after the rodeo. Provide drop off date/time to Aubree French in advance or have the member present during drop-off to ensure proper placement of Rental. This is to ensure trailers are dropped off in the correct assigned spot.

4) **HORSE STALLS:** Locations to be assigned, but member is responsible for bringing or leasing panels. You will be assigned **12ft x 12ft location(s) for your stalls, which are to be attached or butted up against the next stall, per the assigned location(s) on the map.** There should be no spaces between stalls unless shown on the layout. Due to limited space, horse stall(s) may not always be located near your parking stall. If you have a horse that does not get along well with others, please plan on bringing a divider. **DO NOT** ask for more horse stalls than you need. **PLEASE NOTE:** Each contestant will be limited to **one stall per horse event entered, plus one extra stall.** \*There is not always room to tie horses to trailers, if you are bringing a horse, you will need a stall. \*\*Limited number of panels are available for lease, please contact Aubree French for current availability/cost. \*\*\***DO NOT REMOVE/ RELOCATE PANELS THAT ARE NOT YOURS.** \*\*\*\***IT IS VERY IMPORTANT THAT YOU DO NOT PUT YOUR HORSE(s) IN OTHER PEOPLES STALLS!**

5) **2<sup>ND</sup> PARKING STALLS for 2<sup>ND</sup> RIGS:** To be provided on a case-by-case basis, depending on availability and need. **Those who volunteer will get priority.** If you are requesting parking for two (2) rigs, please provide the total length for each rig (trailer with detached truck) in the areas provided on the form. See specific directions after each question on the form below. **NEW THIS YEAR...ALL 2<sup>nd</sup> rigs that do not fit in your assigned parking will be located on the West side hill in the trailer overflow area designated on the map.**

6) **MISSED RODEOS:** If you are not entered in a rodeo, but you still plan to attend and use your parking and/or horse stalls, please contact Aubree French prior to the rodeo to reserve your parking and/or horse stalls. **Otherwise, your parking and/or horse stalls may become available for others to use for that rodeo.**

7) **ALL ASSIGNMENTS ARE SUBJECT TO CHANGE:** Please **review** the updated parking map posted on the D3 Facebook page **before each rodeo.** Updated parking/horse stall map shall be posted Thursday afternoon before each rodeo. For any questions or concerns please contact Aubree French ASAP.

- 8) **ELECTRIC/MOTORIZED CARTS/ETC.:** Electric and/or motorized powered bikes, golf carts, wheels, scooters, UTV, ATV, etc., are **NOT** permitted on the rodeo grounds, except for grounds crew or parking crew. If it is not powered by your own two feet (besides a vehicle) it is not allowed.
- 9) **SPECTATOR/ LESS MOBILE PARKING:** Parking directly behind the grandstands is for the less mobile fans, reserved parking, and vendors. Spectator parking is located along the hill on the west side of the facility or as indicated by signs. **PLEASE DO NOT** park in reserved or numbered parking spots, unless assigned to you.
- 10) **FAILURE** to follow the above REMINDERS, RULES, AND REGULATIONS may result in the relocation and/or loss of assigned parking and/or horse stall(s). Intentional and disrespectful acts against animals and people will be brought to the D3 Boards attention.
