**Truck Identification Sticker Policy**

Once this form is submitted and approved, Eco Waste will issue a unique identification sticker for each registered vehicle listed on this application. Stickers will be mailed to the billing address provided.

Each sticker must be permanently installed on the **driver-side dump body or driver-side cab area** of the truck so it is clearly visible to our cameras when entering the facility. These identification stickers allow us to properly track loads, verify authorized vehicles, and ensure accurate billing for contractor accounts. **All trucks entering under a contractor account must display their assigned sticker.**



# Facility Rules

Eco Waste operates as a fully self service disposal facility with no staff on site

Self service facility hours are:

Monday - Saturday

7:00 AM - 5:00 PM

All loads are **automatically billed daily** at **5:00 PM**

- 🌲 Access is allowed only to approved contractors with an active account or card on file.
- 🌲 Follow all posted traffic patterns and signage within the yard.
- 🌲 Remove tarps and loose materials before entering.
- 🌲 Stay clear of equipment and stockpiles.
- 🌲 High visibility clothing is recommended.
- 🌲 No unauthorized passengers outside vehicles.
- 🌲 All trucks must display and Eco Waste truck ID sticker.
- 🌲 Eco Waste reserves the right to revoke access for rule violations.
- 🌲 All dumping is performed at your own risk.
- 🌲 Follow all posted traffic patterns and signage within the yard.

If a tarp is **not removed prior to entering**, Eco Waste will be **unable to verify the load contents**.

In this situation, the load will automatically be **billed** at the **maximum cubic yard capacity for that truck or trailer size under the Mixed Wood disposal rate**.

Items our facility accepts are priced by the cubic yard.
