Acknowledging the existence of risk, the undersigned accepts all responsibility for such risk and hereby releases and hold harmless, Heather Kimnach, HK Farm, Kimnach, LLC, their employees, and agents of any and all injuries and damages which undersigned's child or the undersigned may engage at or through HK Farm + Kimnach, LLC, Heather Kimnach, their employees and agents.

If, during or in conjunction with lessons or shows at HK Farm + Kimnach, LLC, the undersigned or undersign's child sustains any injury or damages including, but not limited to those described while using the horse or other equine belonging to another person or entity, undersigned agrees to release and hold harmless the owner of said horse or other equine for any damages or injury sustained as a result of said use.

I have been instructed to ride with a safety helmet and riding boots with heels. As an adult, if I elect to not wear a helmet, after being instructed that it is the safe way to ride, I assume all responsibility for injury that might occur for lack of proper protection. I understand that even a properly fitted safety helmet does not insure or prevent all injuries. I acknowledge that a safety helmet meeting

ASTM standards and certified by SEI is required by all minors and adults when mounted. As a parent, I understand that all minor students are required to wear such riding helmet and boots with heels at all lessons or they will not be permitted to ride.

As a parent of other children not receiving instruction, I also assume responsibility for watching my children and keeping them safe and out of the pastures and stalls while on the premises. I understand that HK Farm + Kimnach, LLC, its employees and agents cannot be responsible for the care and protection of other children on the premises during lessons or visits.
