HOUSE RULES

The photographer is limited by the guidelines of the venue or event site management. The Client agrees to accept the technical results of these restrictions. Negotiation with the venue's officials for relaxation of the guidelines is the Client's responsibility; FX Pictures will offer technical recommendations only.

QUANTITY OF IMAGES TAKEN AND SIMILAR IMAGES

To ensure all desired moments are captured and minimize the possibility of errors, some poses and group shots may be taken multiple times or with multiple cameras. This ensures that if someone blinks, if there are background distractions, or if technical issues arise, similar images can still be delivered to the Client. As a result, there may be multiple similar images included in the final delivery.

CHANGE OF DATES

If the Client changes the event date after signing this contract, there may be a fee to move the Assignment to the new date. If FX Pictures is unavailable on the new date, the contract is canceled, and the retainer fee is non-refundable. Please contact us at least 60 days prior to your event to finalize the details.

MUSIC (For Video Services)

If applicable, Clients are required to purchase a legal music license from websites provided by FX Pictures. FX Pictures is not responsible for licensing any music provided by the Client.

Cancellation Policy

If the contracted services are canceled by the Client, the deposit paid is non-refundable. If the event is canceled due to pandemic-related circumstances, the deposit will be credited toward the Client's future event. FX Pictures will be present and provide contracted services on the event day; however, in the event of any unforeseen accident prior to the event that prevents the photographer(s) or videographer(s) from attending, FX Pictures is responsible for providing a replacement. In the rare event that no replacement is available, FX Pictures' liability is limited to refunding all deposits paid.

File Retention

FX Pictures will maintain digital files for a period of six (6) months. The Client is encouraged to make backups and store them in a safe location, as FX Pictures is not responsible for retaining files beyond this period.

Use of Images

FX Pictures reserves the right to use images and/or video from the event for display, publication, or other business marketing/advertising purposes. The Client may use the images for personal, non-commercial purposes only.

MAXIMUM LIABILITY

CLIENT and FX PICTURES agree that in the event of a mechanical failure, or any other reason FX PICTURES is unable to fulfill this contract, FX PICTURES' maximum liability is limited to the return of payments received. FX PICTURES will not be liable for any indirect, incidental, or consequential damages related to this agreement.

LIABILITY OF PHOTOGRAPHER

While every effort will be made to ensure that services are provided as agreed, unforeseen events such as fire, illness, or other causes beyond the Photographer's control may prevent the Photographer from completing the assignment. In such cases, FX Pictures' only liability will be the return of payments made. Similarly, if photographic or video materials are lost or damaged due to equipment malfunction or other reasons beyond the Photographer's control, FX Pictures will return the Client's payment but assumes no further liability.
