### TERMS & CONDITIONS

**EXCLUSIVITY** No other photographer/videographer will be permitted to photograph, pose, direct or interrupt while Fx Pictures, is working. Family and friends of the Client may be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer. Additionally, they will be asked to always stand behind the photographer and video crew. Any breach of this agreement will constitute a reason for non-completion of the job with no liability to the photographer and the loss of all payments made under this contract.

**HOUSE RULES:** The photographer is limited by the guidelines of the ceremony official or reception site management. Client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is Client's responsibility; Fx Pictures will offer technical recommendations only.

### QUANTITY OF IMAGES TAKEN AND TAKING OF SIMILAR IMAGES

In order to ensure that the pictures desired by the couple is recorded and preserved for them, and to lessen the possibility of equipment or photographer error, there are some poses and group shots that will be taken multiple times and/ or with multiple cameras. This is done to ensure that if a person blinks, distractions in the background which are not initially seen, hair, clothes, or equipment (camera, flash, or some other item) fails to work as expected, another image using the same or different camera has also recorded a similar image. This means that there may be multiple similar images delivered to the Client.

**CHANGE OF DATES:** If after a contract is signed the Client changes the wedding date, there may be a charge to move the Assignment to a new date. If Fx Pictures is not available on the new date, the contract is canceled and the retainer fee is not refunded. Please be sure to contact us 60 days prior to your event date to finalize the details.

**MUSIC:** Clients will be required to purchase a legal music license from websites provided by Fx Pictures. Fx Pictures is not responsible for licensing any music provided by client.

**CANCELLATION POLICY:**

If the services contracted are canceled by the client, the deposit paid is non-refundable. If the event is canceled due to the pandemic situation, the deposit will be credited to the client's future event. It is our obligation to be present and provide contracted services on the day of the event; however, in case of any unpredictable accidents before the event day, which may cause disability of the contracted photographer(s) or videographer (s), Fx Pictures responsible for sending a replacement photographer to cover the event. In the event of any unpredictable accidents on the event date, which may cause the absence of the photographer(s), the only responsibility would be to refund the entire amount of paid deposits.

Fx Pictures will maintain the digital files for a period of six months (6 months) and is unable to guarantee retention of the files for more than that.

Fx Pictures reserves the right to use digital images and/or reproductions for display, publication, or other business marketing/advertising purposes. The client may use the images only for personal, non-commercial purposes.

**MAXIMUM LIABILITY:**

CLIENT and FX PICTURES agree that in the event of a mechanical failure, or any other reason, FX PICTURES is unable to provide a functioning pursuant to this agreement, FX PICTURES' maximum liability is the return of any payments received. FX PICTURES Photo Booth will not be liable under any contract, negligence, strict liability, or other theory for direct, indirect, incidental, or consequential damages (including without limitation damages for lost profits or increased expenses) with respect to any claim arising from or related in any way to this agreement, the subject matter of this agreement, the services provided under this agreement or the property where these services are being performed.

FILES Fx Pictures is responsible for maintaining a copy of all Photography/Videography digital files for a limited period of six (6) months after the wedding date. Please be sure to maintain a copy in a fireproof safe for safekeeping as Fx Pictures will no longer be in possession of these files after the six months

**LIABILITY OF PHOTOGRAPHER:**

Although the utmost care will be taken, the Photographer may be unable to deliver the photos due to unforeseen circumstances such as fire, casualty, act of God, illness, or any other cause beyond the control of the Photographer. In this case, the Photographer shall return all money paid and have no further liability with respect to this contract. This limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or memory card malfunction, or otherwise lost or damaged without fault on the part of the Photographer. In the event that the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the value of the Client's contract price stated herein.
