FX PICTURES will not be liable under any contract, negligence, strict liability, or other theory for direct, indirect, incidental or consequential damages (including without limitation damages for lost profits or increased expenses) with respect to any claim arising from or related in any way to this agreement, the subject matter of this agreement, the services provided under this agreement or the property where these services are being performed.

FILES Fx Pictures is responsible for maintaining a copy of all Photography/Videography digital files for a limited period of six (6) months after event date. Please be sure to maintain a copy in a fireproof safe for safe keeping as Fx Pictures will no longer be in possession of these files after the six months

LIABILITY OF PHOTOGRAPHER, FILM MAKER

Although the utmost care will be taken, the Photographer may be unable to deliver the photos due to unforeseen circumstances such as fire, casualty, act of God, illness, or any other cause beyond the control of the Photographer. In this case, the Photographer shall return all money paid and have no further liability with respect to this contract. This limitation of liability shall also apply in the event that photographic materials are damaged in processing, lost through camera or memory card malfunction, or otherwise lost or damaged without fault on the part of the Photographer. In the event that the Photographer fails to perform for any other reason, the Photographer shall not be liable for any amount in excess of the value of the Client's contract price stated herein.

DAMAGE TO PROVIDER'S EQUIPMENT
