# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to 4304 S Rochester Rd, and PKSA Karate Royal Oak-Madison Heights LLC and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, PKSA Karate Royal Oak may collect personally identifiable information, such as your:
