### Facilities/Maintenance Facilitator (Grades K-8)

#### Role

Ensures the safety, cleanliness, and functionality of the school's physical environment to support student learning and staff well-being. The Facilities/Maintenance Facilitator performs preventative maintenance, repairs, custodial tasks, and emergency response duties that uphold ALA's commitment to excellence and order. This role reflects ALA's mission by promoting a secure, healthy, and respectful environment where students and staff can thrive.

### **Authority Level:**

Carries out daily facility and maintenance operations under the direction of the School Administrator. Exercises autonomy in prioritizing routine tasks and responding to urgent facility needs, while adhering to preventative maintenance schedules, safety standards, and school procedures.

### Responsibilities

The Facilities/Maintenance Facilitator plays a vital behind-the-scenes role in supporting ALA's academic and cultural mission. By maintaining a clean, safe, and well-organized campus, this role ensures that the physical environment reflects the school's high standards and supports optimal teaching and learning conditions.

### **Facility Maintenance and Repairs**

- Perform routine and preventive maintenance on plumbing, electrical, HVAC, lighting, and building systems
- Monitor structural integrity and promptly report facility concerns to the School Administrator
- Complete work orders efficiently and maintain documentation of repairs and services performed
- Maintain outdoor areas such as sidewalks, playgrounds, parking lots, and landscape features

#### **Custodial and Cleaning Responsibilities**

- o Clean and sanitize restrooms, classrooms, offices, and high-traffic areas daily
- Restock supplies (soap, paper products, sanitizer) to ensure readiness before and during school hours
- Collect and dispose of trash and recycling materials in compliance with safety and environmental procedures
- Perform scheduled deep cleaning, including carpet extraction, floor waxing, and window cleaning

#### Safety, Security, and Emergency Response

 Conduct regular inspections of emergency exits, fire extinguishers, alarms, and building safety equipment

Open and secure facilities daily by managing keys, door locks, and access points

 Respond to urgent maintenance issues and support emergency drills (e.g., fire, lockdown, weather events)

 Assist with risk assessments and contribute to a safe school environment through proactive maintenance

### **Event Setup and Operational Support**

 Provide logistical support for school assemblies, events, and extracurricular activities (e.g., tables, chairs, equipment setup)

 Move classroom furniture, learning materials, and supplies to support instruction and facility use

 Assist with traffic flow, hallway setup, and signage during arrival, dismissal, and special events
