## 1979 Complaints Start

As early as 1979, personnel in the University's Sports Medicine program and Athletics Department were aware that Strauss was conducting genital examinations on male athletes that were unusually prolonged, and that Strauss refused to allow athletic training staff to be

OSU was able to contain and keep this situation hidden from the victims and public for the entire time Strauss was employed (dating back to 1979), then

for the next 19+ years after he was allowed to retire. Even after Student B specifically requested to be contacted if

this happened to anyone else.
