- Motion made to appoint Diane Meyer to fill Commissioner Position #3, which was vacated by Daniel Burnett: Term 2024-2029, motion seconded, motion carried.
 Secretary Linda will deliver the resolution to County Elections and pick up pertinent information for Diane.
- Mid-term/long-term future projects—new flagpole; 240 niche columbaria; clearing two acres for expansion, including pedestrian and vehicle access; access to water, electricity, eventual replacement of lawn care equipment, new storage shed. We need to give some thought to the expansion of the cemetery and updating several of these items on the property over time; do we want to set some of the money aside for these projects, investing some of the funds we receive from plot sales, etc., lots of possibilities to discuss and decide on in the future. A community meeting to inform folks about these projects, receiving their input and ideas was proposed.
- New cemetery liability insurance: State Farm Insurance has been applied for and we are covered, Secretary Linda will request an official invoice for the county auditor and the coverage package.
- Website discussed; suggested we check with LineTime.org and What's Up Guemes to
 find out if it is possible to post cemetery information on either of these community sites;
 Commissioner Leech will check on purchasing a weatherproof display case for posting
 minutes and cemetery events, which will be installed at the cemetery entrance.
- Correction of cemetery sign, re: "burrial". Objective NLT Memorial Day, 2025
- Financial compensation for Commissioners
