

TERMS OF USE AGREEMENT

Please read this agreement.

This Terms of Use Agreement ("Agreement") is made by and between you or the "Enrollee" and Swan Valley General Store and governs your enrollment in and use of the Swan Valley General Store Rewards service. The next time you use Swan Valley General Store Rewards, you are agreeing to these Terms of Use. If you are not in agreement, please call your local Swan Valley General Store to cancel your Swan Valley General Store Rewards account.

Privacy Policy

Swan Valley General Store respects your right to privacy. Therefore, Swan Valley General Store has adopted the following Privacy Policy: Swan Valley General Store will not sell or otherwise intentionally release personal information (such as name, address, phone number, email address, etc.) to anyone unless you specifically consent to such release in writing.

Use Solely for Personal Purposes

Swan Valley General Store has issued you an account number at your request. You agree to use it for your own personal, family and household purposes according to this agreement. If you allow another person to have your account number, information associated with that person's use will be attributed to your account, meaning that the data associated with any activity undertaken by that person from their use of your account number will be on your account. This also means that any benefits (store credit, coupons, promotions, discounts, and the like) to which you are entitled through your use of the account number may be obtained instead by the person using your account number. You are advised not to let anyone use your account number.

Communications

When you enroll in Swan Valley General Store Rewards, you are agreeing to allow Swan Valley General Store to communicate directly with you regarding changes to its policies, procedures and capabilities. This includes information about new service features, and about information on special promotions and loyalty rewards for account users. For joint accounts, Swan Valley General Store will address communications to the primary account holder.

Your Preference Regarding Personal Information

As an account user, you control how your personal information can be used for purposes other than to complete your transactions. Your preference will be made effective promptly after Swan Valley General Store receives it. You may elect to change your preference at any time.

Enrollee Authorizations

By agreeing to this Agreement, you are authorizing Swan Valley General Store, its affiliates and its subsidiaries to verify your identity in order to proceed with a transaction with Swan Valley General Store which may include redemption of store credit, price discounts, coupons, department credits, and the like, to which you may be entitled. The authorization to verify your identity is essential for participation in Swan Valley General Store Rewards and will remain in effect until you cancel your account.

Member Security

For your security and to help serve you, Swan Valley General Store team members will ask you for photo ID on some Swan Valley General Store Rewards offers. Guests can redeem store or vendor coupons without showing ID. To participate in Swan Valley General Store Rewards, you have been (or will be) issued an account number which links the information on your account to the Swan Valley General Store database. If you suspect that your account is being used without your permission, call Swan Valley General Store immediately so that we can deactivate your account. Swan Valley General Store will issue you a

replacement account only at your request. You agree to cooperate with Swan Valley General Store in any fraud prevention measures that Swan Valley General Store prescribes.

Revocation; Cancellation

If you accept this Agreement, you can participate in the Swan Valley General Store Rewards program as a registered user. If you violate this Agreement, your account will be terminated immediately. Swan Valley General Store may revoke your right to use your account at any time with or without cause, and without giving you notice. You may not use the account after it has been canceled or terminated.

Problems with Goods and Services

Swan Valley General Store makes no express or implied warranties, including of merchantability or of fitness for a particular purpose, regarding the use of the Swan Valley General Store Rewards account or the goods or services obtained from its use.

Information

Swan Valley General Store may provide information to you about their special promotions and loyalty programs if you have selected this preference under the Swan Valley General Store Privacy Policy a copy of the Privacy Policy has been provided above..

Changing this Agreement; Assignment

Swan Valley General Store has the right at any time to terminate or change this Agreement by adding, modifying or deleting any services offered. Swan Valley General Store will consider that you have accepted the change(s) if you use your account number after you receive notice of the changes. You will continue to be responsible for all changes made before you terminate the Agreement. While Swan Valley General Store may assign this Agreement at any time without notice to you, these Terms of Use will remain the same unless you are notified.

Waiver

Swan Valley General Store may not always exercise its rights under this Agreement, but Swan Valley General Store does not give up its rights to exercise them in the future.

Governing Law

The laws of the State of Idaho and applicable Federal law govern this Agreement.

Security of your information

Swan Valley General Store has a number of associates who perform essential support services. These may include employees of companies with whom Swan Valley General Store has contracted to assist in customer care services. Swan Valley General Store limits access only to those associates who need to know such information to provide you with customer care services. Swan Valley General Store and our software service company have instituted a number of physical, procedural and electronic measures to protect your information. We have contractually obligated them to keep your information confidential and in compliance with the preferences you have communicated to us.

Regardless of your preferences, there are times when Swan Valley General Store may be legally required to disclose your personal information. For example, this disclosure may be necessary to comply with a subpoena or similar legal process, or a fraud investigation.
